Sub : Allotment of fund for development of identified backward villages of Jalpaiguri, Purulia and Uttar Dinajpur district.

Sir,

I am directed by order of the Governor to say that the Governor is pleased to accord sanction for an expenditure and make allotment of a total sum of Rs. 728.32 Lakh (Rupees seven crore twenty eight lakh and thirty two thousand) only to the three districts as shown in the following table for taking up various projects for the development of identified backward villages in the districts:-

The projects will be implemented by the PRIs/project implementing agencies as may be identified by the District Magistrate concerned as per guideline for implementation of projects out of fund provided by State Government for intervention in identified backward villages issued by this department vide memo no. 1828(19)-RD/CCA/W/1C-2/2006 dated 12.3.2007 and memo no. 3296(19)-RD/CCA/W/1C-2/2006 dated 14.5.2007.

District Magistrate of the districts concerned will be the Drawing and Disbursing officer for the fund allotted herein. He will draw the fund in advance and transfer it to LF account of the Zilla Parishad.

The charges involved will proceed against the Head of Account “2515-00-196-SP-002-Assistance to ZPs for meeting the critical gap in rural development schemes and other development programmes for Backward Rural Areas-[PN] V-31-Grants-in-Aid -02-Other Grants” in the current year’s budget.

The fund released will be utilized as per the approved cost for items of works only in the identified backward villages in the district for implementation of the schemes approved in this department’s letter no. 559(5)-RD/CCA/1F-1/ 2011 dated 27.1.2012 (for the districts of Jalpaiguri and Uttar Dinajpur) and no. 558(2)-RD/CCA/1F-1/ 2011 dated 27.1.2012 (for Purulia).

The district will submit monthly progress reports (both physical and financial) of works done to this department regularly.
