## ORDER

An amount of Rs.98,55,000/- (Rupees ninety eight lakh fifty five thousand) only has been sanctioned by Housing Department vide No.478(Sanction)-H1/HG/P/1B-14/2009(Pt.XX) dated 10.02.2012 towards new construction of 219 number of dwelling units under Subsidized Ownership EWS Housing Scheme "Ashray" renamed as "Amar Thikana" for the selected beneficiaries in rural areas in the district of Purba Medinipur & Uttar Dinajpur. Sanction has been accorded by Housing Department on the basis of the selected list of beneficiaries under "Amar Thikana" which has been communicated to this Department by the district as detailed below:

- 3) The District Magistrate & Executive Officers of Purba Medinipur & Uttar Dinajpur Zilla Parishad are hereby declared as the DDO in respect of the funds sub-allotted to the district of Purba Medinipur & Uttar Dinajpur, who will draw and transfer the respective funds to the concerned Zilla Parishad's L. F. Account during current financial year.
- 4) The Zilla Parishads will transfer the fund to the L.F. A/cs of concerned Panchayat Samities,' list of beneficiaries of which have been communicated vide Memo. Nos. mentioned in Para-1.
- 5) The Zilla Parishads and the Panchayat Samities will have to keep separate accounts for the funds under the scheme "Amar Thikana".

- 6) Strict observance of the guidelines of "Ashray" renamed as "Amar Thikana" issued and circulated by this Department should be followed.
- 6a) Monthly progress report in the format as circulated vide this Deptt. no.136(19)-RD(IAY)/1R-1/2010 dated 6.1.2011 should be submitted regularly.
- 7) The scheme is to be implemented through Panchayat Raj Bodies on the land belonging to beneficiaries themselves subject to observance of financial formalities. Cost of construction is Rs.45,000/per dwelling unit.
- 8) No deviation from the selected list of beneficiaries will be allowed without prior approval.
- 9) The project is targeted to be implemented as expeditiously as possible. Necessary U.C. of the fund so released should be submitted to the Principal Accountant General (Audit) directly with a copy to this Department and to the Housing Department.
- 10) Monitoring and Advisory Committee should be formed at the Zilla Parishad level for proper monitoring and supervision of the scheme.
