Sub : *Release of Matching State Share under IAY against release of 2nd instalment of Central Share during the year 2010-11 in favour of Burdwan Zilla Parishad.*

Sir,

I am directed by order of the Governor to say that the Governor has been pleased to accord sanction of an expenditure and to make allotment of an amount of Rs.766.396 lakh (Rupees Seven crore Sixty six lakh thirty nine thousand six hundred) only as matching State Share under Indira Awaas Yojana in favour of Burdwan district for implementation of IAY by Burdwan Zilla Parishad. This corresponds to the Central Share of Rs.2299.190 lakh (Rupees Twenty two crore ninety nine lakh nineteen thousand) only sanctioned by the Government of India as 2nd instalment of Central Share of fund during 2010-2011 vide G.O. No. J-12038/1/2010-RH(A/c)- Burdwan-04(2nd instalment) dt. 05.10.2010.

2. The Governor is pleased to declare the Drawing and Disbursing Officer (DDO) of the Directorate of Panchayat & Rural Development (DPRD), West Bengal to act as the DDO in respect of the fund sanctioned and released above. The DDO shall draw the amount as Grant-in-Aid (in new T.R. Form No.31) from the Pay & Accounts Office, Kolkata and to deposit the same in the Fund Transfer Account of the DPRD duly opened in the SBI, Kolkata Main Branch, in terms of this Department Notification No.3116/PN/O/II/3B-5/2005, dated 17.05.2006.

3. The Drawing and Disbursing Officer of the Directorate of Panchayat and Rural Development, West Bengal shall issue an Advice to the State Bank of India, Kolkata Main Branch for transfer of the share of the Burdwan Zilla Parishad from the Fund Transfer (FT) Account of the DPRD in the SBI, Kolkata Main Branch to the FT Account of the Burdwan Zilla Parishad duly opened for the purpose in terms of Notification No. 3116/PN/O/II/3B-5/2005, dated 17.05.2006 of this Department.

4. The Additional Executive Officer of Burdwan Zilla Parishad will release the entire fund directly to the Panchayat Samities immediately on receipt of the fund in the FT Account by issuing an Advice to the concerned branch of the State Bank of India to transfer the shares of the Panchayat Samities within their jurisdiction, from their own FT Account to the FT accounts of the Panchayat Samities duly opened in the nearest SBI Bank branches in terms of Notification No.3116/PN/O/II/3B-5/2005, dated 17.05.2006 of this Department.

5. The Procedure of disbursement of IAY fund to the beneficiaries as detailed under this Deptt's Order No.4906/RD/IAY/17S-04/06 dt. 28.7.09 should be followed. The procedure for collection of data of IAY-MIS as circulated under this Deptt's Order No.4708(57)-RD/PAC(IAY)/17S-04/06(Pt.I) dt.21.7.09 should be followed strictly. Moreover, a Logo of IAY and year of construction will have to be pasted on the wall of the houses made under IAY Scheme.

6. The unit cost of an IAY house as per enhanced rate with effect from 01.04.10 vide this Deptt. No. 2670(20)-RD/PAC(IAY)/17M-3/2008 dated 21.04.10 in accordance with No. G-20011/1/2010-RH, dated 05.04.10 of the Government of India should be followed in case of houses sanctioned on or after 1.4.2010.
7. No contractor/middleman shall be engaged. The work shall not be executed departmentally by the Panchayats. The beneficiaries will be given the fund as grant in two instalments as per IAY Guidelines and they will construct their own house.
8. The IAY fund (Central share as well as the State share) shall be kept in a Nationalised Bank in an exclusive and separate interest bearing Savings Bank Account by the Panchayat Samities.
9. The amount of Rs.766.396 lakh (Rupees Seven crore sixty six lakh thirty nine thousand six hundred) allotted herein as Matching State share under Indira Awaas Yojana Scheme against central release of 2nd instalment of IAY to Burdwan Zilla Parishad. The accounts for this amount are to be kept separately.
10. Beneficiaries will be selected from the permanent wait list of IAY finally approved by the Gram Panchayats. The clarification circulated vide this Department's No. SPRD-1919(18)-07/RD/P/PAC(IAY)/17S-04/2006, dated 19.09.2007 and order No. 3362(18)-RD/P/PAC(IAY)/17F-03/08, dated 18.04.08 should be strictly followed in this regard.
11. Gram Panchayatwise allocation of fund is to be made on the basis of the revised criterion formulated by the Government of India by giving 75% weightage on housing shortage and 25% weightage on SC/ST population.
12. Utilization reports in respect of fund sanctioned herein must be sent to this Department in due course in the latest format as per guidelines of IAY.
13. The fund so allotted is towards plan expenditure and will be utilized for approved items of works as per condition laid down in the guidelines of IAY. No deviation from the provisions of the guidelines is permissible.
14. The charge involved against State share of fund of Rs.766.396 lakh (Rupees Seven crore sixty six lakh thirty nine thousand six hundred) only will be debited to the following heads of A/c. as shown below from the vote-on-account budget 2010-11 under the demand No.40 as detailed against each :
