ORDER

BRGF ALLOTMENT ORDER NO. 4

The Governor is hereby pleased to accord sanction and to place a total grant of **Rs. 7.33 Crores** (Rupees seven crore thirty three lakh) only, on account of payment of central assistance under BRGF to the district of **Dakshin Dinajpur** for annual plan 2009-10 received vide order no. N-11019/243/2009-BRGF dated:7.6.10, from the Ministry of Panchayati Raj, Government of India for three tiers of Panchayat Bodies and Urban Local Bodies of the district as per statement enclosed herewith (**Annexure-A,**) on the basis of the norms adopted for allotment of fund recommended by the 2nd State Finance Commission.

2. The present release is made out of the provision for development grant under BRGF against schemes in the approved District Plan of the respective districts in accordance with the BRGF Programme Guidelines.

3. The Drawing and Disbursing Officer of the Directorate of Panchayats and Rural Development (DPRD), West Bengal, who is hereby declared as the DDO in respect of the fund sanctioned and released, as above, shall draw the amount as Grant-in-Aid under new T.R. Form No. 31 (Old T.R. Form No. 48) from the Pay & Accounts Office, Kolkata, and deposit the same in the Fund Transfer Account of the Directorate of Panchayats and Rural Development (DPRD), West Bengal, opened for this purpose in the SBI, Kolkata Main Branch, in terms of this Department's Notification No. 3116/PN/O/II/3B-5/2005 dated 17.05.06 read with this department's Notification No. 3416/PN/O/II/3B-5/2005 dated 2.8.2007.

4. The charges in this respect are debitable to the on account provision under the heads of accounts as follows:-

- i) "2501-01-789-Special Component Plan for SC-SP-004-Backward Region Grant Fund(BRGF)[PN]-V-31-02"—Rs.3.665 crores.
- ii) "2501-01-796-Tribal Areas Sub-plan-SP-003-Backward Region Grant Fund (BRGF) [PN]-V-31-02" – Rs.1.466 crores.
- iii) "2501-01-800- Other Expenditure-SP-007-Backward Region Grant Fund (BRGF) [PN]-V-31-02" –Rs.2.199 crores.

Shares of the Zilla Parishad, Panchayat Samitis and ,Gram Panchayats of each district calculated on the basis of their entitlements shall be transferred by the DDO of the DPRD, West Bengal from the Fund Transfer (FT) Account of the DPRD in the SBI, Kolkata Main Branch, to the Fund Transfer (FT) Account of **Dakshin Dinajpur** Zilla Parishad.

5. The DDO of the Directorate of Panchayats & R.D., West Bengal, shall transfer the total amount of Rs. **7.33 Crores** as shown in the Annexure-A **directly** to the Fund Transfer (FT) Accounts of **Dakshin Dinajpur** Zilla Parishad and Zilla Parishad, in turn, will transfer the fund to the

respective tier & institutions of PRIs as shown in the Annexure-A in terms of this Department G.O No. 1406-PN/O/II/3B-5/2005 dated 24.3.2009.

6. The fund will be utilized and accounts will be maintained in accordance with the Chapter-4 of the BRGF Guidelines. Monthly Progress Report in the prescribed format will be submitted by the 8th day of the following month. Utilization Certificate will also be submitted in prescribed format.

7. The fund shall be utilized for implementation of BRGF against schemes in the approved District Plan of the district in accordance with the BRGF Programme Guidelines.

8. Allotment of fund is no authority to incur any expenditure unless such expenditure is covered by sanction of the appropriate rules/authority. Under no circumstances any expenditure should be incurred in excess of allotment or in deviation of the guidelines/procedures prescribed in respect of this fund.
