ORDER

In continuation of this Department's earlier Order No.1600-RD(IAY)/17F-02/2010 dated 08.03.2010 the balance amount of Rs.4,01,10,000/- (Rupees four crore one lakh ten thousand) only has been released by Housing Department vide No. 202(Sanction)-HI/HG/P/1B-14/2009(Pt.II) dated 19.08.2010 towards completion of 2292 number of dwelling units under Subsidized Ownership EWS Housing Scheme "Ashray" for the selected beneficiaries in rural areas of 47 number of blocks in the districts of Malda, Nadia, North 24-Parganas and Purulia. It is mentioned that an amount of Rs.8,02,20,000/- (Rupees eight crore two lakh twenty thousand) was sanctioned and Rs. 4,01,10,000/- (Rupees four crore one lakh ten thousand) was released by Housing Department vide No.389(Sanction)-H1//HG/P/1B-14/2009 (Pt.II) dated 18.02.2010 for construction of new houses under Ashray scheme. 3) The District Magistrate & Executive Officer of the respective Zilla Parishads are hereby declared as the DDO in respect of the funds sub-allotted to them who will draw and transfer the respective funds to the concerned Zilla Parishads' L. F. Account.

- 4) The Zilla Parishad will transfer the fund to the L.F. Account of concerned Panchayat Samities'; list of beneficiaries of which has been communicated vide Memo Nos. mentioned in Para-1
- 5) The Zilla Parishads and the Panchayat Samities will have to keep separate accounts for the funds under the scheme "Ashray".
- 6) Strict observance of the guidelines of "Ashray" issued and circulated by this Department should be followed.
- 7) No deviation from the selected list of beneficiaries will be allowed without prior approval.
- 8) The project is targeted to be implemented as expeditiously as possible. Necessary U.C. of the fund so released should be submitted to the Principal Accountant General (Audit), directly with a copy to this Department and to the Housing Department. For further release of balance fund, the Zilla Parishads will have to send proposal to this Department.
- 9) Monitoring and Advisory Committee should be formed at the Zilla Parishad level for proper monitoring and supervision of the scheme.
- 10) Plan heads as mentioned in para 2 have been newly opened during 2009-2010 vide Housing Department's G. O. No.641-HG/P/HI-1P-4/2009 dated 23.10.2009 with approval from Principal Accountant General (A&E), W.B., vide his Memo No. AM-1/3-37/1X/472 dated 22.10.2009.
