- 5) The Zilla Parishad and the Panchayat Samities will have to keep separate accounts for the funds under the scheme "Ashray".

- 6) Strict observance of the guidelines of "Ashray" issued and circulated by this Department should be followed.
- 6a) Monthly progress report in the format as circulated vide this Deptt. no.136(19)-RD(IAY)/1R-1/2010 dated 6.1.2011 should be submitted regularly.
- 7) No deviation from the selected list of beneficiaries will be allowed without prior approval.
- 8) The project is targeted to be implemented as expeditiously as possible. Necessary U.C. of the fund so released should be submitted to the Principal Accountant General (Audit), directly with a copy to this Department and to the Housing Department. For further release of balance fund, the Zilla Parishad will have to send proposal to this Department.
- 9) Monitoring and Advisory Committee should be formed at the Zilla Parishad level for proper monitoring and supervision of the scheme.
- 10) Plan Heads as mentioned in para 2 have been newly opened during 2009-2010 vide Housing Department's G. O. No.641-HG/P/HI-1P-4/2009 dated 23.10.2009 with approval from Principal Accountant General (A&E), W.B., vide his Memo No. AM-1/3-37/1X/472 dated 22.10.2009.
