ORDER

**Sub: - Grant of Dearness Relief to the Pensioners / Family Pensioners of
Panchayats including Panchayat Karmee w.e.f. 1st January, 2012**

In continuation of this Department's order No. 7983-PN/N/III/2P-32/99 dated 03/12/2010 sanctioning an instalment of relief to the Pensioners/ Family Pensioners of Panchayati Raj Bodies with effect from 01/12/2010 onwards, the undersigned is directed to state that the Governor is pleased to sanction Dearness Relief to the Pensioners / Family Pensioners of Panchayats including Panchayat Karmee @ 45% with effect from 1st January, 2012 onwards in supersession of the rate mentioned in the order dated 03/12/2010 as mentioned above.

2. Payment of relief on Pension / family Pension involving a fraction of a rupee shall be rounded off to the next higher rupee.
3. It will now be responsibility of the Pension Disbursing Authority to calculate the quantum of relief on Pension / Family Pension payable in each individual case.
4. For the purpose of relief sanctioned herein, the Director of Pension, Provident Fund & Group Insurance, Purta Bhawan, Bidhan Nagar, Kolkata-700091, will issue authority to the Public Sector Banks in Kolkata and Accountant Generals of the other States.
5. The Treasury / Sub-Treasury Officers in this State will give effect to this order without any further authorization from the Director of Pension, Provident Fund & Group Insurance, Purta Bhawan, Bidhan Nagar, Kolkata-700091.
6. This benefit of Dearness Relief as has been sanctioned in this order is applicable in respect of the Pensioners / Family Pensioners of Panchayats including Panchayat Karmee who are in receipt of Dearness Relief @ 35% of basic pension with effect from 1st December, 2010.
7. This order issues in exercise of the power delegated under the Finance Department (Pension Branch) Memo No. 843-F (Pen) dated 14/12/2011.




