#### **Outline Scope of Work:**

The tentative scope of Architect and Design consultant may include but not to be limited the following main tasks containing to the relevant guidelines of PMGSY and Project Agreement with the ADB.

# **RRNMU**: - (1) Burdwan Town (2) Midnapore Town (3) Jalpaiguri Town and (4) Malda Town.

Tentatively 2/3 Storeyed Building:-

Provision for Laboratories, Staff, Computer Network Management and GIS operator, Technical Branch, Guest House etc. Approx floor area :- 1250 Sq. M for each location

#### **Eligibility Criteria:-**

The Prospective bidder shall satisfy the followings:-

- i) Architect/Architectural firm shall have at least 10 years of standing in the profession after registration with the Council of Architecture. In case of company or firm at least one of the Directors or Principals shall be licensed Architect registered with Council of Architects as per Architects Act 1972 with minimum 10 years in the field of Architecture and the Company shall be in existence in the field for 10 years. Experience in the Design of the field offices, training/research centre and industrial buildings suitable to tropical conditions based on best International standards and utilizing green concept including utilizing sustainable energy will be added advantage.
- ii) Architect/Architecture firm shall have in hand or have had completed building project and had provided comprehensive architectural design services as principal consultant (s) for at least one relevant similar project costing Rs. 5.00 Crore or more in the last 5 years in the State of West Bengal.

iii) Architect/Architecture firm should also have the relevant experience particularly in Designing and detailing infrastructure required for similar buildings with modern state of Art Technology with emphasis in Information Technology.

- 1) The project building complex are proposed to be green building complex with the highest rating as per desired level of certification. This will be the key aspect required to be considered while finalizing the design project concept. Based on above the focus of the concept shall be on the International Standard of Green Building accreditation.
- 2) Reviewing the concept Architectural Drawing and discussion with the client.
- 3) Taking client's instruction & proper design brief.
- 4) All services and materials shall be as per National Building code.
- 5) Allied Services :- a) Land scaping b) Modular furniture.
- 6) Architectural Design will utilize "Green concept suitable to tropical conditions including utilizing sustainable energy sources, eco-friendly materials etc.
