**CORRIGENDUM**

**Memo No.1376/RD/O/MGNREGA/18M-01/12**

**Dated: 27.02.2012**

In the REQUEST FOR PROPOSAL FOR Design, Development, Implementation and Maintenance of an end to end ICT Solution for MGNREGS in West Bengal issued from the Panchayats & Rural Development Department, Government of West Bengal, Reference No. 01/ MGNREGS/2012 dated 20.02.12 as well as the CORRIGENDUM Memo No.1344/RD/O/MGNREGA/18M-01/12 Dated: 24.02.2012) the following additional changes are made:

In paragraph 2.1, in place of "The Panchayat & Rural Development Department, Government of West Bengal has decided that it will engage suitable e-governance implementing agency / organization / company through a QCBS process for such purpose."- will be replaced by "The Panchayat & Rural Development Department, Government of West Bengal has decided that it will engage suitable e-governance implementing agency / organization / company/ Consortium through a QCBS process for such purpose."

After 2.1, a new paragraph as detailed below is inserted:

2.1.1 If bidder is Consortium, the partners would be limited to three (including lead partner). Consortium firm shall jointly and severally be responsible for completion of the project. Consortium must fulfill the following minimum qualification requirements:

1. The lead partner shall meet not less than 50% of all of the qualification criteria given in Clause 2.6b (Page-9).
2. Each of the remaining partners shall meet not less than 25% of all the qualifying criteria given in Clause 2.6b (Page-9).
3. The consortium must also collectively satisfy the criteria given in Clause 2.6c, 2.6d and 2.6f (Page-9). For this purpose the relevant figures for each of the partners shall be added together to arrive at the total capacity of the consortium, which shall be 100% or more.
4. The lead partner or any other member of the Consortium shall meet the qualification criteria given in Clause 2.6e (Page-9).
5. All the members of the Consortium shall meet the criteria given in Clause 2.6a and 2.6g (Page-9).
6. Consortium applicants shall provide a certified copy of the consortium agreement in demonstration of the partners undertaking joint and several liabilities for the performance of any contract entered into before award of work. Statement of intent to participate in the Consortium has to be submitted at the time of application.

The following may be **read with** Clause 5 (Payment terms, page 18 and 19 of the RFP)

The Govt. reserves the right to evaluate the phase-wise activities in consultation with the System Integrator selected and reschedule the payment clause with or without imposing a performance linked incentive or penalty at each phase of the contract schedule.
