TERMS & CONDITIONS

- 1. The bidder must be a reputed Firm dealing with sales, distribution, installation and maintenance of branded Computers, Computer hardware, Computer accessories and Software including LAN hardware and software and have its registered office in Kolkata.
- 2. The Firm should be well equipped with qualified professionals as well as with sufficient stock of items of procurement including spare parts compatible with existing computers operative in the Zilla Parishad.
- 3. The Firm should be capable of undertaking proper maintenance work at the site of installation within 24 hours of intimation free of cost within warranty period which should be not less than one year of the date of installation and against the charges mutually settled and payable by the Zilla Parishad beyond the warranty period.
- 4. Earnest Money Deposit along with the Tender will be of Rs. 5000 (Rupees five thousand only) in the form of Bank Draft drawn in favour of "Additional Executive Officer, South 24 Parganas Zilla Parishad" payable in Kolkata of a nationalized Bank.
- 5. Record of similar nature of work executed with Govt.
 Departments/ Offices along with value of work per year during last 3 years should be furnished with the Tender.
- 6. Sales Tax/VAT Registration and latest ST/PT Clearance Certificates should be enclosed.
- 7. Particulars with contact details of professional personnel at the disposal of the Firm should be provided. Such personnel should have required qualification to provide services for Windows XP/Linux based network.
- 8. On-site warranty for materials supplied and its smooth function would be of at least 12 months.
- 9. UTP cable laying through PVC casing and installation of I/O & Faceplate and termination of CAT6 at 10 and Jaqck Panel would be required for LAN. Bid should include such incidental costs.
- 10. The Bidder has to undertake that all of the aforesaid terms and conditions will be duly complied with and an agreement to this effect together with maintenance of quality and quantity of items to be supplied and installed would be executed before the formal offer is awarded.
