- i) The prospective tenderers shall have satisfactory completed during the last 5 (five) years from the date of issue of this Notice at least one work of similar nature inb the Govt. sector, Zilla Parishad, Panchayat Samity, block or Gram Panchayat or Public sector undertaking and having a magnitude of **50** (**fifty**) percent (price updated @ 10% per annum and part there of, compoundable from the date of completion of work) of the amount put to tender. Only completion certificate and also payment certificate of the work will be considered as credential in this respect.
- ii) Valid Income Tax/Sale Tax/Professional Tax Clearance Certificate/Sale Tax Registration Certificate/ VAT Registration Certificate and copy of Pan Card to be accompanied with Tender documents. Income Tax and VAT return Acknowledgement Receipt for latest assessment year to be submitted.

Such **abandonment or rescission** will be considered as disqualification towards eligibility.
