The quotations should be addressed to the The Additional Executive Officer, North 24 Parganas, Barasat, North 24 Parganas Zilla Parishad and should reach latest by 07th May 2010 by 2:00 p.m. and the offers should be marked "Quotation for Desk Tops, etc". The rates should be inclusive of all taxes. The bids will be opened by 07th May at 4:00 p.m.. The tenderers/ their authorized representatives may remain present during the opening process.
2. Details of local "After Sales Service Facility" including name, address, contact Nos. etc. should also be mentioned in the offer.
3. Quotations for products of lower configuration / model other than specified above will be summarily rejected. Rates must be shown in figures as well as in words. All alterations in the rates should be signed in ink; otherwise the quotation / offer will not be considered. In case of any variance between the amounts quoted in figures and in words, the quotations will be summarily rejected.
4. The quotation should be signed by the authorized person and his full name and status should be indicated below his signature.
5. The quotations should be valid for at least 3 months. The delivery period would be 2 weeks from the acceptance of offer and issue of order. For any delay in the supply of goods by the specified date, a liquidated damage of 0.5% of the delivered price of the delayed goods for each week or part thereof subject to a maximum limit of 10% of the delivered price of the delayed goods, will be charged for a number of weeks or part thereof for which the computer is supplied after the specified date given in the supply order.
6. Quotations received late after due date and time will be summarily rejected.
7. Catalogues / full particulars of the branded computer should also be furnished with the quotation.
8. Computer shall be supplied and installed at the premises of the North 24 Parganas Zilla Parishad situated at Barasat, Rishi Bankim Sarani, Kolkata 700 124 as per requirement of this office.
