In view of the above facts, technically, qualifying bidders will be selected Three to Five in Number (as per decision of the Government) who fulfills the maximum qualifying aspects right from conceptual drawing work to finish of the project work in terms of Men, Machineries, Equipments, Soil Test etc with experience for similar type of work/s as a prime agency, Financial and Technical personnel soundness proof or any other proof to show the agency's bonafiedness what so ever may follow by a unique number gradation in all sector (to be decided by Government during Technical bid finalization) so that minimum Technical qualifying bonafiedness will be minimum 75% out of 100% aggregate number. In this regards, decision of Government and binding to the agency. No claim/protest/plea what so ever in any form will be treated as disqualifier and could be produced in the court of law.
