Cost of Pre-qualification and bid document is Rs 3000.00 for on-line bids. Intending bidders may download the tender documents from the website directly with the help of Digital Signature Certificate & necessary Earnest Money deposit /cost of tender documents will be received by NET BANKING through ICICI BANK PAYMENT GATEWAY or through RTGS/NEFT system as detailed in Finance Department's website vide memorandum no. 3975-F(Y) dt. 28.07.2016.

The pre-qualification documents alone will be opened on 16.09.2019 (Monday) at 11.00 Hours. by the Executive Engineer, Paschim Medinipur Zilla Parishad in presence of bidders.

Names of the technically qualified bidders on the basis of information furnished in the checklist and in "Bidders1 and Bidders2" uploaded by concerned bidders after verification of the same with original, will be displayed in the portal and this office notice board subject to completion of verification and technical evaluation.

No separate intimation will be given for this, unless the above date is changed. In case of change of date and any corrigendum, due intimation will be given in Website. No individual intimation will be given. Name of the qualified bidders will be displayed in the office notice board

The financial bid documents of the technically qualified bidders will be opened after scrutiny subjected to completion of technical evaluation and verification of original document. Others bid documents will be unopened. List of financial comparison chart of bidders will be published. No separate intimation will be given online. No individual intimation will be given and the same shall be placed before tender committee for their recommendation and put up for acceptance according to decision by the authority of Paschim Medinipur Zilla Parishad.

The Executive Engineer, Paschim Medinipur Zilla Parishad / Zilla Parishad authority reserves the right to reject or cancel any or all pre-qualification documents and bid document without assigning any reason whatsoever.

The eligibility criteria are given below: -

Achieved in any one year during last three years in the same name and style (excluding current year) a minimum financial turnover and at least 60%(sixty percent) of which is from civil engineering construction works) equivalent to amount given below: -

- 1.i) 60% of amount put to bid (cost of construction only) in case of the amount put to bid is Rs. 200 lakh and less.
- ii) 75% of amount put to bid (cost of construction only) in case of the amount put to bid is more than Rs. 200 lakhs for which bid has been invited. The turnover will be enhanced at the rate of 8% for a completed financial year.
- 2) The applicant in the same name and style as prime contractor should have successfully completed at least one contract of same type of work at least 40% (Forty Percent) value of the proposed contract within the last 5 years.
- 3) Income Tax return should be submitted for last 3 years. (scan copy)

- 4) The Contractor should have necessary Bid capacity to execute the work (documentary evidence in proof of the above four items should be enclosed)
- 5) Trial balance or accounting sheet on the turnover, debit, credit position at least for the three years (Audited)
- 6) GST Registration, Trade License, Voter ID/ AADHAAR & Professional Tax clearance certificate & Pan Card, paying slip of EM, bid document (Xerox copy), Technical Persons, Prime Machineries should be furnished (Scan Copy).
- 7) To qualify for a Road scheme of contracts made up of this and other contracts for which bids are invited in the NIT, the bidder must demonstrate having experience and resources sufficient to meet the aggregates of the qualifying criteria for individual contracts. The amount of earnest money is 2% of the estimated cost for "Upgradation of Road from Duan Sitala Mandir to Badal Chakarborty House ( 0.0 KM to 0.95 KM ) under Debra I P.S. area in the dist of Paschim Medinipur".

The Additional Performance Security shall be obtained from the successful bidder, if the accepted bid value is less than 80% of the estimated amount put of tender, from a successful bidder, having own prime machineries required for the particular type of work. If a successful bidder does not have ownership of any of the prime machineries required for the particular type of work, the Additional Performance Security shall be obtained from the successful bidder if the accepted bid value is less than 90% of the estimated amount put to tender.

The Additional Performance Security shall be equal to 10% of the tendered amount.

All duties, taxes, royalties, Cess, [including 1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Act, 1996], toll, taxes and other levies payable by the Contractor under the Contract to the State / Central Government for any other cause, shall be included in the rates, prices and total Bid price submitted by the bidder. 1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Welfare Cess Act, 1996 will be deducted from the running bills.

#### GST deduction will be applied as per Govt. Order.

To keep the Road in good condition during the next Two years after the completion of the construction if any additional / excess work is required over the stipulated quantity in the schedule for routine maintenance work, the same will be treated as defect liability and the contractor has to do the maintenance work at his own cost. Security deposit will be released 50 % in each year.

Time allowed for completion of package is four months from the date of issue of work order.

The intending bidders are requested to inspect the alignment of the proposed road before quoting their rates.
