ORDER

Indira Gandhi National Old Age pension (IGNOAPS) , Indira Gandhi
National Widow Pension(IGNWPS) , Indira Gandhi National Disability
Pension(IGNDPS)(RURAL) – 2/2012-13

The Governor is hereby pleased to accord sanction a total grant of **Rs 77,38,23,500/-** (Rupees seventy seven Crore Thirty eight Lakh Twenty three Thousand Five Hundred Only), comprising of a Central Share of **Rs. 40,65,53,250/-** [Rupees Forty Crore Sixty five Lakh Fifty three Thousand Two Hundred fifty] Only and a State Share of **Rs. 36,72,70,250-**[Rupees thirty six Crore Seventy two Lakh seventy Thousand Two Hundred fifty] only towards implementation of the Indira Gandhi National Old Age pension (IGNOAPS) , Indira Gandhi National Widow Pension(IGNWPS) , Indira Gandhi National Disability Pension(IGNDPS)(**RURAL**) for the month May, 2012-13, **for disbursement as shown in annexure A** and to place at the disposal of the Director of Panchayats and Rural Development, West Bengal.

2. Pension to the beneficiaries can be disbursed only through the Bank Accounts or the Post Office Accounts of the beneficiaries concerned.

3. The Drawing and Disbursing Officer of the Directorate of Panchayats and Rural Development (DPRD), West Bengal, who is hereby declared as the DDO in respect of the fund sanctioned and released, as above, shall draw the T.R. Form No. 31 from the Pay & Accounts Office-I, Kolkata, and deposit the same in the Fund Transfer Account, opened for this purpose by the DPRD in the SBI, Kolkata Main Branch, in terms of this Department's Notification No. 3116/PN/O/II/3B-5/2005 dated 17.05.06 & 1406-PN/o/II/3B-5/2005 dated 24.03.09.

Keeping in view the total amount of a district, **as shown in the Annexure-A**, the District Panchayat & Rural Development Officers shall, within one week of crediting of the transferred amount in the respective designated Bank Account, again transfer such amounts to the concerned designated Bank Accounts of all the **Panchayat Samity**.
