Intended bidders are advised to read the following Addendum:

Part – A

To avoid any Ambiguity/Misinterpretation of the intention of the NIEI, It is clarified that the End-to-End contract shall mean Right from preparation of conceptual drawing/s to construct the Building works as a Prime Contractor by formation of consortium as explained in Part: B Para (i) of the NIEI No. 131/RD/SGSY (NOW NRLM)/20M-4/06 (Part) dated 11.02.2013.

In this context, the Parameters as have been covered under Part – A of the said NIEI remains unaltered. Further the Intended Bidder/s are advised to be prepared to submit the Financial Bid who will be declared Qualified through our Website: www.wbprd.nic.in on the last date of opening Technical Bids (i.e. 21.02.2013) or through passing a Qualifiers list as Hard Copy which will cope up situation at that time suitably.

The Bidders are required to submit their bids under different subheads with reference to the prevailing current specification as per latest P.W.D. schedule of Rates for Building and Sanitary and Plumbing works, Electrical works or for any non schedule items Analysis of Rates should be made with reference to 3 (three) quotations relating to each Rate Analysis to be taken in consideration which should intern requires to be approved by the Department. In doing the Building Analysis, the Site Plan and the Soil Investigation Report may be collected from the undersigned before submitting the Financial Bid. In case of Financial Bid the subhead wise Rate to be quoted both in figure and words on the basis of detail quantity survey or any other means of Quantity Evaluation but Quoted rate to be taken into account both for Acceptance and Payment on the approved and executed item and quantities. All subhead total will be taken into a single one and the rate so arrived at will be taken into account for Rate acceptance both for approval and execution. No additional cost what so ever in any manner except the subhead wise items quoted by the Bidder/s will be paid separately. For any excess, supplementary, substituted supplementary item/s work will be taken up as per the prevailing Departmental Rules/or any other rules as deem fit by the Government as per necessity of the completion of the Project and discretion of the Department will be treated as final.
