The details of the terms and conditions of the above service are given below:-

Terms & Conditions

- a) The period of AMC will initially for one year which may be extended for further period on same terms & conditions & price, based on satisfactory performance and discretion of the P&RD Department.
- b) Technical support for diagnosis of fault and rectification.
- c) This comprehensive AMC includes replacements/repairs (excluding Compressor) of parts, refilling of gas etc.
- d) Onsite support for correction of hardware problems.
- e) All major and minor Hardware replacement for damage due to high voltage and lightening.
- f) Problem diagnosis and rectification on entire system.
- g) Coverage should be 24 hrs X 7 days in a week.
- h) The bidder will deploy a well conversant engineer who will reach P&RD Department, Salt Lake within 1-2 hours of receiving complaints from this department. The bidder is also liable to provide immediate support as and when informed by this department on holidays. The bidder must provide contact number of office and mobile no. of service engineer & proprietor.
- i) The bidder should be equipped with his own mechanical, electrical and electronic tools to attend all the activities.
- j) One mandatory visit is to be made in every month in working days (during normal working hours is 10.00 hrs to 17.00 hrs) for preventive maintenance. One preventive service every six months for each AC machine is mandatory.

- k) The visit should be duly certified by the authorized staff of P&RD Department out of mandatory visit. P&RD Department may trigger any other visit. Bidder should file the report to P&RD department after duly signed by the authorized officer.
- I) The contract shall be for the full quantity as described above.
- m) Corrections, if any, shall be made by crossing out, initialing, dating and re-writing.
- n) GST leviable shall be excluded from the total price.
- o) Support service for any problem must be attended within the frame mentioned above. Otherwise penalty for delay in service must be charged as per the discretion of P&RD department.
