#### Bidding Document for Zilla Parishad Work (Jhargram Zilla Parishad)

The Executive Engineer, Jhargram Zilla Parishad reserves the right to reject or cancel any or all pre-qualification documents and bid document without assigning any reason whatsoever.

The eligibility criteria are given below: -

Achieved in any one year during last five years in the same name and style (excluding current year) a minimum financial turnover and at least 50% of which is from civil engineering construction works) equivalent to amount given below: -

- 1). The turnover will be indexed at the rate of interest 8% for a completed financial year.
- 2) The applicant in the same name and style as prime contractor should have successfully completed at least one contract of **same nature of work**, at least **20% (twenty percent)** value of the proposed contract within the last 5 years.
- 3) Income Tax return should be submitted for last 2 years.
- 4)Sales Tax & Professional Tax clearance certificate & Pan Card (Xerox copy) paying slip of (EM, bid document) should be furnished (Scan Copy).
- 5) Acknowledgment receipt of EM deposited.
- 1)To qualify for a Package of contracts made up of this and other contracts for which bids are invited in the NIT, the bidder must demonstrate having experience and resources sufficient to meet the aggregates of the qualifying criteria for individual contracts.

The amount of earnest money is 2% of the estimated cost for "Construction of first floor administrative building over existing ground floor in the back side of the compound of Jhargram Zilla Parishad"

The Additional Performance Security shall be obtained from the successful bidder, if the accepted bid value is less than 80% of the estimated amount put of tender, from a successful bidder, having own prime machineries required for the particular type of work. If a successful bidder does not have ownership of any of the prime machineries required for the particular type of work, the Additional Performance Security shall be obtained from the successful bidder if the accepted bid value is less than 90% of the estimated amount put to tender.

The Additional Performance Security shall be equal to 10% of the amount put to tender. All duties, taxes, royalties, Cess, GST [including 1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Act, 1996], toll, taxes and other levies payable by the Contractor under the Contract to the State / Central Government for any other cause, shall be included in the rates, prices and total Bid price submitted by the bidder. 1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Welfare Cess Act, 1996 whichever is applicable will be deducted from the running bills.

The intending bidders are requested to inspect the site of proposed building before quoting their rates.
