- 1). The turnover will be indexed at the rate of interest 8% for a completed financial year.
- 2)The applicant in the same name and style as prime contractor should have successfully completed at least one contract of Building/Bridge/Concrete road work, at least one-third value of the proposed contract within the last 5 years.
- 3) Income Tax return should be submitted for last 2 years.
 - 4)Sales Tax & Professional Tax clearance certificate & Pan Card (Xerox copy) paying slip of (EM, bid document) should be furnished (Scan Copy).
