

1. All the participants should enclose photo copy of PAN, Income Tax Return of last assessment year, VAT Return of last quarter, Profession Tax clearance certificate, Trade Licence etc.
2. Price Rates/Bids should be inclusive of all taxes, duties, transport/delivery charges of printing materials to 19 district offices of West Bengal ( under this Office) as per distribution plan available in this office. The district offices are located in District HQs in West Bengal.
3. No tender will be accepted after the specified date and time. No further correspondence will be entertained in this matter.
4. WBSRLM reserves right to accept or reject any price rates/bids without showing reason or any correspondence whatsoever.
5. Purchase Order will be issued to the selected bidder with details of printing matter, price delivery, liquidated damage, pre/post delivery inspection provisions, warranty and other essential terms and conditions including contract agreement.
6. After completion of delivery of books in good condition to all the district offices as per distribution plan, payment will be made through A/C payee cheque/ NEFT to the Printers against their bill with the challans duly acknowledged by the districts official.
7. 2% security deposit is required to be deposited by selected Bidder. After completion of delivery of books in good condition to all the district offices, the same will be refunded.
8. Delivery of printing materials shall be completed within 15 days of final editing/ approval of the printing matters.
