**Subject :- Clarification on the date of effect 18.10.2012 regarding NFBS.**

**Fact :**

- (1) Rate of NFBS has been increased from Rs.10,000/- to Rs.40,000/-
- (2) Date of effect : 18.10.2012.
- (3) Order of enhancement of support issued on 28.03.2013.
- (4) Upper age limit has been lowered to 59 from 64.

Now clarifications in respect of some queries raised thereupon are stated below,

Sl. No.	Queries	Reply
1.	Date of effect is to be treated as the date of death or the date of application.	Already clarified vide Memo No.1659 dated 25.04.2013 that date of effect will be the date of death.
2.	If date of death is before 18.10.2012. But the date of sanction is after 18.10.2012 and age of deceased is in the age group 60 to 64.	Support will be given in previous rate (i.e. Rs.10,000/-)
3.	If date of death is after 18.10.2012 and sanction date is between 18.10.2012 to 28.03.2013. and age of deceased is between 60 to 64.	Support will be given in previous rate (i.e. Rs.10,000/-).
4	If date of death is after 18.10.2012, sanction date is between 18.10.2012 to 28.03.2013, age of deceased is between 18 to 59 and support has already been given in old rate i.e, Rs. 10000/-	Balance amount will be given to cover the enhanced rate w.e.f. 18.10.12.

No fresh sanction will be given after 28.03.2013 to the family if the age of deceased is in the age group 60 to 64 and date of death is on or after 18.10.2012.
