Prescribed Format for submission of Tender and the Specified Schedule will be available in the Engineering Section of Dakshin Dinajpur Zilla Parishad during office hours and will be supplied to the intending Tenderers free of cost.

Important Information

Earnest Money : The participation charge/tender documents purchase fee and the earnest money should be deposited through savings account no : 31194254645 (SBI, Balurghat) in favour of DDZP. The Xerox/scanned copy of counter foil subscribing participation charge or earnest money as the case may be must be submitted at the time of dropping tender.

3. Without Xerox copy or scanned copy of Participation Charge and EMD the bid will be treated as non-responsive.
4. The application for issuing Tender Documents of the prospective bidder will be considered only if the bidder found qualified according to the minimum qualification criteria as mentioned in this NIT by the "Tender Committee" formed by Dakshin Dinajpur Zilla Parishad and the decision of the Authority.
5. The bidder shall submit all the technical papers, credential Certificate, Earnest Money, Participation Charge receipt etc. in cover-1 Subscribing "Technical Bid".

The 2nd cover will contain the % Offered rate in the from of % below/above/at PAR. The 2nd cover will be subscribed as "Financial Bid".

7. Eligibility criteria for participation in tender :

- The prospective tenderers shall have satisfactory completed during the last 5 (five) years from the date of issue of this Notice at least one work of similar nature inb the Govt. sector, Zilla Parishad, Panchayat Samity, block or Gram Panchayat or Public sector undertaking and having a magnitude of 50 (fifty) percent (price updated @ 10% per annum and part there of, compoundable from the date of completion of work) of the amount put to tender. Only completion certificate and also payment certificate of the work will be considered as credential in this respect.
- Valid Income Tax/Sale Tax/Professional Tax Clearance Certificate/Sale Tax Registration Certificate/ VAT Registration Certificate and copy of Pan Card to be accompanied with Tender documents. Income Tax and VAT return Acknowledgement Receipt for latest assessment year to be submitted.
- The prospective tenderers or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility. (A declaration in this respect has to be furnished by the prospective bidders without which the Bid shall be treated non-responsive).

- iv) Registered Unemployed Engineers' Co-Operative Societies are required to furnish valid Bye Law, Current Audit Report, Certificate from A.R.C.S. along with other relevant supporting papers.
- v) A tenderer who happens to be a member of a Firm or Joint Venture should be allowed to participate within individually or as a member of the Firm or Joint Venture.
7. Running payment for work may be made to the executing agency by Secretary, DDZP or Additional Executive Officer, DDZP or Executive Officer, DDZPas per availability of fund and as per norms.
8. **Constructional Labour Welfare Cess @ 1 (one) % of cost of construction will be deducted from every Bill of the selected agency.**
9. **Escalation of price on any ground and consequent cost over runs shall not be entertained under any circumstances. So the Bidders are requested to examine the rates of each & individual items before quoting the percentage rate of the total work.**
10. In connection with these works, **no arbitration** will be allowed.
11. **No mobilization/secured advance** will be allowed.
12. **Price Preference** will be allowed as per Govt. Order No. 1110-F, Dated- 10.02.2006.
13. The Tender, at the Tenderer's own responsibility and risk is encouraged to visit and examine the site of works and its surrounding examine the schedule of works, rates etc. and obtain all information that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice Inviting Tender, the cost of visiting the site shall be at the Bidder's own expense.
14. Prospective applicants are advised to note carefully the **minimum qualification criteria** as mentioned in the Tender Notice before tendering the bids.
15. The bidders should note that the offer made by participants in 1st call of the vide NIT No.13 dt- 27.07.2012 are not opened yet. After getting the response in 2nd call All bids will be evaluated simultaneously. The bidders who had participated in the 1st call if want to enhance their rates may participate and offer their rate in 2nd call also. In such case the participation charge and earnest money will not be required, **however the earnest money and participation charge are to be supplemented in Technical Bid.**
16. **The above Clause-15 will not be applicable for bidders who had submitted PC and EM in the form of bank draft. As such their bids are qualified in the 1st call. These bidders may put up fresh bid by depositing PC and EM in designated account.**
17. If the tender opening day happens to be a holiday then the tender will be opened on next working day at the same time.
18. Authority of Dakshin Dinajpur Zilla Parishad reserves the right to reject any tender without assigned any reason.
