WBSRDA invites Quotation in Sealed cover from the **Domestic Consulting Firms** for the preparation of Detailed Project Report in connection with the construction of **Extension Training Centre** in the District of **Paschim Medinipore** within **15.01.2015 (Thursday) by 2.00 PM.**

**Eligible Criteria:**

1. Successfully completed at least one work of 50% floor area (7500 sft approx.) of the proposed building.
2. Average annual turnover for the last 3 years must not be less than 40% of the amount of quoted rate.

**Scope of Work:**

1. The Consultant must carryout all necessary soil investigation at least two pits of the proposed site.
2. The Consultant must submit one conceptual drawing for getting approval from competent authority.
3. After getting approval, Consultant will prepare D.P.R. and all structural design, drawings and will link all necessary steps for obtaining approval from the statutory bodies.
4. The Consultant will also submit the B.O.Q. both soft copy and hard copy for invitation of tender.

**Mode of Payment:**

The Consultant will get 50% on obtaining approval from statutory bodies and the balance amount will be released after getting administrative approval from the competent authority.
