The service being transferable, the incumbents shall be liable to be transferred to any part of the State at any time in the interest of public service whenever required.
6. It is hereby certified as per Note 3(i) under rule 11 of WBSR, Pt-1 that the medical certificate in the prescribed proforma has been obtained in respect of all above mentioned candidates prior to their appointment and nothing adverse has been found and kept at this office.
