**ORDER**

Shri Soumya Brata Ghosh, Assistant Engineer of this Department under RWP set up and posted at Purba Medinipur Zilla Parishad is hereby allowed to be released on DEPUTATION to enable him join the post of Manager (Tech) in National Highway Authority of India (NHAI) for a period of three (03) years w.e.f. the date Shri Ghosh is released from his present place of posting.

Shri Ghosh will have to join his present post after the DEPUTATION period is over or will have to take necessary permission from this office in case his DEPUTATION period is extended.
