The NIT No., Serial No. and/or UTR number should be clearly mentioned on the deposit challan. Payment made otherwise will be rejected.

The pre-qualification documents alone will be opened on **01/03/2013 (Friday) at 2.00 PM** by the Addl. Executive Officer, Murshidabad Zilla Parishad in presence of bidders present.

The financial bid document of the technically qualified bidders will be opened for evaluation and selection of qualified bidders on **06/03/2013 (Wednesday) at 2.00 PM** and the other bid documents will be unopened. No separate intimation will be given for this, unless the above date is changed. In case of change of date, due intimation will be given in News dailies. No individual intimation will be given. Name of the qualified bidders will be displayed in the office notice board.

The Addl. Executive Officer, Murshidabad Zilla Parishad reserves the right to reject or cancel any or all pre-qualification documents and bid document without assigning any reason whatsoever.

The eligibility criteria are given below:-

- 1) Upto date renewal receipt copy & receipt copy of security deposit should be submitted/uploaded with the tender documents (Self attested xerox copy/Scanned copy).
- 2) Receipt copy of deposit (Cost of Tender Paper) challan should be submitted/uploaded with the tender documents.
- 4) Income Tax return should be submitted/uploaded for the last financial year with the technical bid.
- 5) Sales Tax, Professional Tax receipt Challan for the year 2012-2013, VAT registration Certificate & Pan Card should be furnished/uploaded (Self attested xerox copy/Scanned copy).
- 6) Each Bidder shall submit maximum three Bids in each NIT. A Bidder who submits more than three Bids for one NIT will cause the proposals with the Bidder's participation to be disqualified.
- 7) The partnership firm shall furnish the registered partnership deed and the company shall furnish the Article of Association and Memorandum.
- 8) Affidavit attested by Notary Public should be submitted/uploaded with the tender documents.[format enclosed with SBD]
- 9) The documents which will be submitted should be self attested (applicable for off-line submission).

The amount of earnest money is 2% of the estimated cost of construction for each work. All duties, taxes, royalties, cess, [including 1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Act, 1996], toll, taxes and other levies payable by the Contractor under the Contract to the State / Central Government for any other cause, shall be included in the rates, prices and total Bid price submitted by the bidder. **1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Welfare Cess Act, 1996 will be deducted from the running bills.**
