- 5. Payment: The TSA will claim 25% of the annual contract price after completion of quarterly deliverables as mentioned in ToR. The TSA will prepare district wise work done duly certified by the DMMU and enclose the same with quarterly claim.. The payment to the TSA will be made within 30 days from the date of submission of bill, if it is found in order.

- 6. Completion Schedule: The entire work will be completed within thirty six months as detailed in para 7 (deliverable year-1, 2 & 3) hereunder. You shall submit the work completion schedule for various activities and the schedule shall be strictly followed by you.
