ABRIDGED NOTICE INVITING EXPRESSION OF INTEREST (EOI) {2nd Call}

P&RD Department is going to take up Construction of an electric burning ghat (Electric Crematorium Complex) at Tarapith Maha Smashan, Sahapur & Kharun GP under Rampurhat-I & II Block in the District of Birbhum. Consequently, Preparation of Detail Project Report (DPR) is required.

Therefore, for Preparation of Detail Project Report (DPR) for Construction of the said electric burning ghat (Electric Crematorium Complex) at Tarapith Maha Smashan, sealed EOI are hereby invited by the undersigned from resourceful & bonafide Consultants having experience in the field of preparation of similar kind of DPR.

MAIN FEATURES OF THE DPR SHOULD BE :

- The crematorium should house 2 (Two) units of Electric operated Cremator.
- In the operating system, there should be Air pollution control and energy recovery system for the said cremator units.
- The project proposal should consider overall Pollution Control System, suitable Rest – Shed, beautification of the premises, provision of gender specific washing & bathing facilities. There should be provision and proposal of other basic amenities including water supply.
- The area should be made pleasant by setting a garden or greenery with decent aesthetic view as a whole by keeping parity with the existing heritage Complex of the Tara Ma Mandir.

SCOPE OF WORK


1. Conduction of Detailed Survey, Soil investigation and collection of any other field data required for preparation of DPR.
2. Recommendation of the Crematory System and type of the Crematorium to be constructed.
3. Design of Foundation, sub-structure, Super-structure, and any other nature of structural design required for the purpose.
4. Preparation of detail drawings.
5. Preparation of Detail Estimate supported by the detail Rate Analysis.
6. The Environmental Impact should be taken into consideration and necessary provisions should be made accordingly.
7. The Project Proposal should support Feasibility Report.
8. BOQ & SOQ alongwith all the necessary Tender Documents are to be prepared as a part of DPR.
9. Submission of at least 4 (Four) hard copies of DPR in the form of booklet in presentable manner and one soft copy in Re-Writable CD.
10. Vetting of the DPR from appropriate authority after verification of the same from this end will be required.

TERMS AND CONDITIONS :

1. The offer of rate should be submitted in sealed cover addressed to the undersigned within the date and time specified herein.
2. Prior to submission of Formal Proposal and offer of Consultancy Charges, the Intending Consultant should visit the site of work at his / her / their own cost.
3. The Intending Consultant should state the DPR Preparation Charges on lump sum Basis over the Project Cost and, the same should be quoted both in fig. and words.
4. The Intending Consultant should submit self attested copies of documents in support of proof of the Experience for similar nature of work. PAN, Trade License, documents in support of proof of the PT, IT, etc along with the offer document.
5. The successful Consultant(s) should execute an Agreement with the Department as per prevailing norms.
6. The stipulated time for Preparation of DPR will be Thirty days.
7. The Consultancy charges will be paid after acceptance of the project Proposal by the authority. Necessary deductions towards all relevant and applicable Taxes, any other statutory deduction will be made accordingly.
8. THOSE WHO DID NOT PREPARE ANY DPR OF THE SIMILAR PROJECTS NEED NOT APPLY.

The last date for submission of Quotation is 06.04.2015 Upto 02-00 PM and the same will be opened on the same day after 03-00 PM in presence of the available participating Consultants.


