

Examination 2018 Gr.-C Services & Posts conducted by Public Service Commission, West Bengal, after verification of antecedents. The service being transferable, the incumbents shall be liable to be transferred to any part of the State at any time in the interest of public service as and when required.
6. It is hereby certified as per Note 3 (i) under rule 11 of WBSR, Pt-1 that the medical certificate in the prescribed proforma has been obtained in respect of all above mentioned candidates (Gr. A Officer) prior to their appointment and nothing adverse has been found and kept at this office.




