1.	Whether work to be awarded to a single Consultant or split into three (3) Consultant.	Will be decided by the Department after evaluation, if situation demands.
2.	QCBS Ration	The Ratio of Quality : Cost shall be 60 : 40
3.	Discrepancy in Amount of Earnest Money.	The Amount of Earnest Money is Rs. 1,00,000.00 (Rupees One Lakh) only.
4.	The length of road is not specified.	The length of the road shall be decided by the Department as per requirement. All roads shall be either under Zilla Parishad or under WBSRDA.
5.	The Building site and Area has not been mentioned.	The Site and Area of the Building shall be as per requirement of the Department in future.
6.	“Bidder shall visit the site”. Site not provided.	Any where in West Bengal after assigning of the work.
7.	Drawing is a part of the RFP. No Drawing provided.	Drawing implies in this case is Drawing/Photograph of the Projects claimed as credential supporting Document.
8.	Whether the Consultant shall submit three (3) different proposal for three (3) different packages.	A format for Financial Bid has been published in the Corrigendum where Bidder shall submit three (3) different rates for Building, Roads and Bridges. The Volume – I Section 3A published in Page No. 26 & 27 of RFP should not be submitted under Volume – I of RFP and the Section 3A is deleted.
9.	The Duration of the work is not mentioned.	The Duration of the engagement of “End to End Consultant” shall be three (3) years. The period of engagement mentioned in Page No. 3 vide NIT No. 645-WBSRDA/2E-15/10 Dated 21.03.2012.
10.	Authority who shall provide the space for Site Office during Survey and Soil Investigation.	The Zilla Parishad / District WBSRDA Unit shall provide the space for Site Office.
11.	Return of the Bid Security to the successful Bidder.	The Bid Security shall be retained as Security Deposit in Addition to Performance Security and Both will be released after successful execution of the tender.

- 2) In NIB No. 646-WBSRDA/2E-15/10 Dated 28.03.2012 in Page No. 4 of RFP Document under Heading line No. 4 the Consultancy of Major Civil Engineering Works should be read in place of Building Works.
- 3) The Bidder should submit Volume – I (RFP Document), Volume – II (Terms of Payment) and Volume – III (Financial Offer). The Packet – I (Technical Bid) should contain Volume – I alongwith supporting documents essential for qualification as per Clause No. 3.0 of RFP duly signed including Bid Security/Earnest Money and Cost of Bidding Document. The Earnest Money and Cost of Bidding Document should submit in two (2) separate sealed cover under Packet – 1.

The Packet – II (Financial Bid) should contain Volume – II (Terms of Payment three numbers for Building, Bridge and Road Works) and Volume – III (Financial offer for Building, Bridge and Road Works) duly signed by the Bidder.

Both Packet – I and Packet – II should submit under one sealed cover The Name of Work as “**Engagement of End to End Solution Consultant**” and the **Name of the Bidder should clearly be written on the cover.**
