Sub: Submission of Report on 3rd SFC grant for Gram Panchayats under ISGP Project

Sir,

The Finance Department of the Government of West Bengal has agreed vide their U.O.No. 0287 Group-N dated 01-06-2012 to release 3rd SFC grant to ISGPP G.Ps, treating a particular Gram Panchayat as a unit. In other words, 3rd SFC will be released to a GP which has qualified for next instalment even if district may not qualify as a whole. This norm holds good for ISGP Project Gram Panchayats only as of now, as performance based grant cum incentive system is firmly in place for such GPs.

I am now directed to request you to submit a consolidated as well as GP wise report in the prescribed proforma (enclosed) regarding **at least** 50 percent utilisation of the first instalment or first two instalments together whichever is applicable as on 31st May 2012 **for GPs covered in ISGP Project only.**

Please send the report of 3rd SFC grant utilisation by ISGP Project GPs as on 31st May 2012 to the ISGPP Cell of P&RDD by **15th June 2012** and subsequently such report be sent to the undersigned by e-mail within 10th of every following quarter ending. Please treat this as extremely urgent.


