For and on behalf of the Dakshin Dinajpur Zilla Parishad, the Executive Engineer (P&RD),Dakshin Dinajpur Zilla Parishad, invites sealed percentage rate tenders for each of the following works by two cover system. The pre-qualification and bid documents duly filled in all respect should be submitted on-line through our e-portal before 15.00 Hours (as per server clock) on 24.09.2013. Dakshin Dinajpur Zilla Parishad does not take any responsibility for the delay caused due to non-availability of Internet connection or traffic jam etc. for on-line bids. The pre-qualification documents alone will be opened at 12.00 Hours on 25.09.2013, by the Executive Engineer (P&RD), Dakshin Dinajpur Zilla Parishad in presence of available bidders present.

The financial bid document of the technically qualified bidders will be opened for evaluation and selection of qualified bidders on at 12.00 Hours 27.09.2013, and the other bid documents will be unopened. If the dates are changed due to un-avoidable circumstances intimation will be given in website and office notice board. No individual intimation will be issued in this connection

**Eligibility Criteria for Participation in tender & Information to Bidders.**

1. The intending bidders should have successfully completed at least one contract of Building/Bridge work, at least of 40% value of the proposed contract within last 5 years from the date of publication of the notice. Such work executed should be in the Government Sector, Zilla Parishad, Panchayat Samiti, Gram Panchayat or Public Sector undertaking. The completion certificate and payment certificate issued by competent authority will be considered as credential in this respect.
2. Attested copies of valid Income Tax,(Pan card), Sale Tax/VAT, Professional Tax Certificate must be uploaded in appropriate folder. Registered Engineering Co-Operative Society and Registered Labour Co-Operatives must upload the Bye-Laws, and other papers and submit the same will full address of their authorized persons to sign the tender documents along with technical Bid papers. During scrutiny of Technical Bid/Tender documents if it is found that any information is incorrect the technical bid/tender documents will be rejected without assigning any reason thereof. The Tender Committee of Dakshin Dinajpur Zilla Parishad will have sole discretion to decide the eligibility of ,the Contractors on the basis of his submitted documents and evaluation and reserves the right to refuse any explanation to the Contractor without assigning any reason thereof and the decision of the Zilla Parishad Authority will be final in this respect. All papers will be verified with original papers as when required.
3. Intending bidders have to submit their bid on-line through e-procurement portal of Zilla Parishad of P & RD Deptt <http://www.wbprd.nic.in> The participation charge and the earnest money should be deposited through savings account no : 31194254645 (SBI, Balurghat) in favour of DDZP. The scanned colour copy of counter foil (subscribing the NIT No. and SL No. and duly signed by the contractor/his representative over it) of participation charge or earnest money as the case may be must be uploaded in the appropriate folder.

4. Bids from joint venture are not allowed.
5. The indenting bidders should know the fact 'that the rates in the BOQs are **inclusive** all duties, taxes, royalties, cess, [including 1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Act, 1996], toll, taxes and other levies payable by the Contractor under the Contract to the State / Central Government for any other cause, shall be included in the rates, prices and total Bid price submitted by the bidder. **1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Welfare Cess Act, 1996 will be deducted from the running bills.** No. separate claim on any circumstances will be allowed.
6. In this tender no arbitration will be allowed.
7. At least one degree engineer, one diploma engineer and one laboratory technician to be deputed at work site at the time of execution and their documents in this effect must be uploaded in appropriate folder.
8. Relevant certificate from any Nationalised Bank in proof of financial solvency need must be uploaded in appropriate folder.
9. The intending Tenderers should furnish a list of works executed by them / him / her of similar nature and magnitude as mentioned above with necessary certificate from the concerned Executive Engineer or an Engineer of same rank or above of any Government / Government undertaking regarding satisfactory performance of such works to be submitted at the time of receiving tender. In absence of the above details tender may not be accepted.
10. All the related documents are to be produced **IN ORIGINAL** to this office as and when asked for.
11. No Mobilization/Secured advance will be allowed to selected agency.
12. Running payment for work will be made to the agency by Executive Officer, Dakshin Dinajpur Zilla Parishad/ Additional Executive Officer, Dakshin Dinajpur Zilla Parishad/ Secretary, Dakshin Dinajpur Zilla Parishad as the case may be as per availability of fund and as per norms.
13. The intending bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 05(five) years. Such abandonment or rescission will be considered as disqualification towards eligibility. Declaration in this respect has to be furnished by the intending bidders in the form of affidavit without which the bid will be treated as non-responsible.
14. The bidders at their own responsibility and risk is encouraged to visit and examine the site of works and its surrounding and obtain all information that may be necessary for preparing the bid and entering into a contract for the work mentioned in the Notice. The cost of visiting the site shall be at the bidder own expense.
15. Dakshin Dinajpur Zilla Parishad authority reserves the right to reject any or whole tender without assigning any reason thereof.

- x. Registered Engineers' / Labour Co-operative Societies are required to submit the eligibility certificate ( for being entitled to participate in this tender for the period it is meant for ) from the respective ARCS.
- xi. In case of Partnership Firm / Registered Company, the intending Tenderers are requested to submit the copy of the DEED of Partnership / relevant document in support of proof of so.

**Terms and Conditions:**

1. All the Intending Tenderers are requested to visit the sites of works prior to the submission of Tender at their own effort and interest.
2. This Notice Inviting Tender will be treated as part of the Tender Document.
3. In case of any day, meant for this tender, appears to be an unscheduled holiday, the next working day will be treated as scheduled / prescribed day for the same purpose.
4. No materials, Tools & Plants etc. will be issued by Dakshin Dinajpur Zilla Parishad.
5. No preconditioned tender will be accepted.

6. All the rates of works are inclusive of all taxes, cess, levy, octroi, royalties, transportation, loading, unloading, stacking, etc including all other incidental charges therein.
7. The Successful Tenderer, herein after called the Contractor, will have to execute an agreement on a Non Judicial Stamp worth Rs. 100/- only.
8. Time & Cost over-run will not be permitted. In case of any work not being completed by the contractor within the stipulated time-frame, necessary Penal Measure, in the tune of deduction of an amount, as decided by the Artha-Sanstha-Unnayan-O-Parikalpana Sthayee Samity of Dakshin Dinajpur Zilla Parishad, will be imposed.
9. The Contractors are required to set well equipped laboratory for exercising effective quality control. Periodical tests on materials and works shall have to be conducted as per relevant codes. Suitable Laboratory Assistants are to be posted in the Laboratories for the same. The results of all quality control tests and observations should be required for getting any payments. No claims regarding payment will not be entertained without quality control test including certificate of Engineers.
10. Necessary deduction towards VAT, Income Tax and Welfare Cess etc. will be made as per Govt. norms, and Security Deposit @ 8% of the value of work will be deducted from each progressive Bill. The Earnest Money will be converted in the form the Security Deposit.
11. Each bonafied tenderer irrespective of the fact whether he / she is a Degree or Diploma holder must have in his / her employment at least one Degree holder & one Diploma holder in Civil Engineering and to be posted at site, and the document in this effect to be submitted along with tender.
12. The successful contractor shall have to submit 3 (three) copies of application in the prescribed form for license (Form No VI) duly filled and signed by the contractor along with the tender. The license fee in terms of Rule - 26(2) and the Security Deposit of Labour in terms of Rule - 24 of West Bengal Contract & Labour (Regulation & Abolition) Act, 1972 should be separately deposited to the Local Treasury under the Head of Account - : 843 Civil Deposit - Deposit under various central and State Acts deposit under the contract Labour (Regulation and Abolition) Act, 1970.
13. Sub-allotment of work under any circumstances will not be permitted.
14. Any bill (running account/final) payment of proposed executed work may be made to Agency as per availability of fund under MSDP.
15. For exemption of the initial earnest money the registered cooperative should submit the registration certificate, By Law of their cooperative from competent authority with Technical bid.
16. Escalation claimed by the Agency will not be entertained by Authority.
