The pre-qualification and bid documents duly filled in all respect should be submitted on-line through our e-portal before 12.00 Hours (as per server clock) on 19-11-2012. Dakshin Dinajpur Zilla Parishad does not take any responsibility for the delay caused due to non-availability of Internet connection or traffic jam etc. for on-line bids. The pre-qualification documents alone will be opened at 12.30 Hours on 19-11-2012, by the Executive Engineer (P&RD), Dakshin Dinajpur Zilla Parishad in presence of available bidders present.


The financial bid document of the technically qualified bidders will be opened for evaluation and selection of qualified bidders on at 13.30 Hours 19-11-2012, and the other bid documents will be unopened. If the dates are changed due to un-avoidable circumstances intimation will be given in website and office notice board. No individual intimation will be issued in this connection

Eligibility Criteria for Participation in tender & Information to Bidders.

1. The intending bidders should have successfully completed at least one contract of the same type of work, at least of 50% value of the proposed contract within last 5 years from the date of publication of the notice. Such work executed should be in the Government Sector, Zilla Parishad, Panchayat Samiti, Gram Panchayat or Public Sector undertaking. The completion certificate and payment certificate issued by competent authority will be considered as credential in this respect.
2. To qualify for award of contract, each bidder should have achieved in any one year during the last five year in the same name and style(excluding current year) a minimum financial turnover as certified by Chartered Account and at least 50% of which is from civil engineering construction works equivalent to amount given below. The turnover will be indexed at the rate of 8% for a completed year (i) 100% of amount put to bid in case of the amount put to bid is up to Rs.25 Lakh for which the bid has been invited.
3. Attested copies of valid Income Tax, (Pan card), Sale Tax/VAT, Professional Tax, Clearing Certificate must be up loaded in appropriate folder. Registered Engineering Co-Operative Society and Registered Labour Co-Operatives must upload the Bye-Laws, valid Audit report for the last 03(three) years, **valid ARCS certificates** and other papers and submit the same with full address of their authorized persons to sign the tender documents along with technical Bid papers. During scrutiny of Technical Bid/Tender documents if it is found that any information is incorrect the technical bid/tender documents will be rejected without assigning any reason thereof. The Tender Committee of Dakshin Dinajpur Zilla Parishad will have sole discretion to decide the eligibility of the Contractors on the basis of his submitted documents and evaluation and reserves the right to refuse any explanation to the Contractor without assigning any reason thereof and the decision of the Zilla Parishad Authority will be final in this respect.
4. Intending bidders have to submit their bid on-line through **e-procurement portal of Zilla Parishad of P & RD Deptt** [http: www.wbprd.nic.in](http://www.wbprd.nic.in) The participation charge/tender documents purchase fee and the earnest money should be deposited through savings account no : **31194254645 (SBI, Balurghat) in favour of DDZP**. The scanned copy of counter foil (subscribing participation charge or earnest money as the case may be must be uploaded in the appropriate folder.
5. Bids from joint venture are not allowed.
6. The indenting bidders should know the fact 'that the rates in the BOQs are **inclusive** all duties, taxes, royalties, cess, [including 1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Act, 1996], toll, taxes and other levies payable by the Contractor under the Contract to the State / Central Government for any other cause, shall

be included in the rates, prices and total Bid price submitted by the bidder. **1% Cess under W.B Building and other Construction Workers (Regulation of Employments & Condition of Service) Welfare Cess Act, 1996 will be deducted from the running bills.** No. separate claim or any circumstances will be allowed.

- 7 In this tender no arbitration will be allowed.
- 8 No Mobilization/Secured advance will be allowed to selected agency.
- 9 Price preference and exemption of EMD is allowed as per G.O. No. – 1110-F dt- 10.02.2006.
- 10 Running payment for work will be made to the agency by Executive Officer, Dakshin Dinajpur Zilla Parishad , Additional Executive Officer, Dakshin Dinajpur Zilla Parishad , Secretary, Dakshir Dinajpur Zilla Parishad as the case may be as per availability of fund and as per norms.
- 11 The intending bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 05(five) years. Such abandonment or rescission will be considered as disqualification towards eligibility. Declaration in this respect has to be furnished by the intending bidders in the form of affidavit without which the bid will be treated as non-responsible.
- 12 The bidders at their own responsibility and risk is encouraged to visit and examine the site of works and its surrounding and obtain all information that may be necessary for preparing the bid and entering into a contract for the work mentioned in the Notice. The cost of visiting the site shall be at the bidder's own expense.
- 13 Dakshin Dinajpur Zilla Parishad authority reserves the right to reject any or whole tender without assigning any reason thereof.


