**ORDER**

**Sub: Grant of Interest-free Festival Advance to the PRI Bodies employees for the year 2022-23**

The undersigned is directed by order of the Governor to say that the regular employees of Zilla Parishads/Siliguri Mahakuma Parishad, Panchayat Samitis and Gram Panchayats and the regular employees of DRD Cell of Zilla Parishads/SMP/GTA whose revised emoluments as on 31st March, 2023 exceeded Rs.39,000/- per month but did not exceed Rs. 49,000/- per month who apply for interest-free festival advance, may be granted an advance up to a maximum of Rs. 16,000/- (Rupees sixteen Thousand) only during the ensuing festival.

2. The benefit of interest-free festival advance may also be allowed to (a) the whole time piece rated workers, either permanent or temporary and (b) the employees belonging to work charged/contingent establishments. Such employees drawing revised emoluments exceeding Rs.39,000/- per month but not exceeding Rs 49,000/- per month on 31st March, 2023 may be allowed to draw the interest free festival advance of Rs. 16,000/- only, if they apply for the same.

3. In case of the employees falling under para (2) above, the authority sanctioning the advance shall certify after being satisfied that the employee is likely to continue in service until the recovery is completed.

4. The advance sanctioned herein will be recovered from the salary of the employees concerned in not more than 10(Ten) monthly instalments. If the amount of advance is exactly divisible by ten, it will be recovered in ten equal monthly instalments. If not, the figure obtained by dividing the amount by Ten should be rounded off to the nearest rupees which will be the amount of each of the first nine monthly instalments, and the balance will be recovered in the tenth monthly instalment. The same method of calculation will apply mutatis-mutandis where the advance will be repaid in less than ten instalments. The recovery of the advance sanctioned under this order will begin either from the salary of the employees for the month of November, 2023 or from the salary for the month following the month in which the advance is drawn, whichever is later. However, recovery in all cases should be completed by the 31st August, 2024, at the latest.

5. The employees of Zilla Parishad/ Siliguri Mahakuma Parishad, Panchayat Samities and Gram Panchayats and the employees of DRDC of ZPs/SMP/GTA who will leave/ retire from the service on a date after issue of this order but before 1st November, 2023 will not be allowed any festival advance. However, an employee who will retire after 1st November 2023 will be eligible for interest-free festival advance sanctioned in this order subject to the condition the recovery should be completed on or before the month of superannuation.

6. (a) Persons who entered into service under the Zilla Parishads/Siliguri Mahakurna Parishad, Panchayat Samitis and Gram Panchayats and DRDC of ZPs/SMP/GTA for the first time after 31<sup>st</sup> March, 2023 but before 1<sup>st</sup> October, 2023 and who are not eligible to get the benefit of Ad-hoc bonus for the year 2022-2023 will be entitled to the benefit of interest free-festival advance as sanctioned above subject to fulfilment of the terms and condition laid down in this order. Their emoluments for the purpose of payment of advance will be determined on the basis of their emoluments at the time of entry into service.

(b) The benefit of interest-free festival advance sanctioned above will also be admissible to the employees of Zilla Parishads/Siliguri Mahakuma Parishad, Panchayat Samitis, Gram Panchayats and DRDC of ZPs/SMP/GTA who have been appointed on regular or contract basis provided they are not eligible to draw ad-hoc bonus on pro-rata basis sanctioned for the accounting year 2022-2023 and provided their regular or contract emoluments did not exceed Rs. 49,000/- per month.

7. The benefit of interest-free festival advance sanctioned above will also be admissible to the Confidential Assistants to the Sabhadhipaties belonging to temporary establishment of the Zilla Parishads/ Siliguri Mahakuma Parishad.

8. The term 'emoluments' in the case of employees drawing pay and allowances in the un-revised scale, will include basic pay, personal pay, special pay, specialist pay, dearness pay, dearness allowances, deputation (duty) allowance and special allowance (additional remuneration). For the employees who are drawing pay in the revised scale the term 'emoluments' will mean basic pay drawn in the applicable Level in the Pay Matrix, dearness allowance and non-practicing allowance, if any.

9. Application for interest-free festival advance on the strength of this order by the employees of three tiers PR Bodies and the employees of DRDC of ZPs/ SMP/GTA shall be made in case of Muslim employees before the Festival of ID-UL-FITRE and in case of other than Muslim employees should be made in between 03.10.2023 to 06.10.2023.

10. The expenditure incurred for payment of interest-free festival advance to the employees of Zilla Parishads/Siliguri Mahakuma Parishad, Panchayat Samitis and Gram Panchayats and the employees of DRD Cell of ZPs/ SMP/GTA will be debited from the provision made during the current financial year 2021-2022 under the concerned salary head of account of the aforesaid employees of the three tiers of Panchayati Raj Bodies viz :-

i) "012-Grants-in-aid/contributions to the Zilla Parishads Contribution towards salaries of the employees of the Zilla Parishads [PN]-V-36-Grants-in-aid-Salaries-00",

ii)"010-Grants-in-aid/contribution to Panchayat Samitis-Contribution towards salaries of the employees of Panchayat Samitis [PN]-V-36-Grants-in-aid-Salaries-00",

iii)"004- Contribution towards salaries of Employees of Gram Panchayats [PN]-V-36-Grants-in-aid-Salaaries-00"

**Under head of account** Administrative Expenditure "2515-Other Rural Development programmes-00-101-Panchayati Raj-00" in the current financial year.

iv) The expenditure incurred for payment of interest-free festival advance to the employees of DRD Cells of Zilla Parishads/ Mahakuma Parishad/ DGHC will be met from the provisions for salaries of the said employees received in the designated bank accounts by the respective Zilla Parishads/ Mahakuma Parishad/GTA from the State Government as well as the Government of India in the current financial year.
