ORDER

In pursuance of P & R. D. Department's Notification No. 309-RD/O/13E-55/02(Pt-II) dated 21.01.2022 and Notification No.2683-PRD-31018(11)/4/2024-ESTT SEC-Dept. PRD, dated: 12.06.2025, respectively, Shri Biswajit Patra, Executive Engineer, under West Bengal Senior Service of Engineers (Civil) of Panchayats & Rural Development Department is hereby allowed to get the Promotional benefit as on 10.02.2022 and 15 years under the MCAS'2001 w.e.f. 01.08.2023 in terms of Finance Department Memo No. 5100-F(P1)/FA/O/2M/46/23 (N.B) dt. 31.08.2023, read with Memo No. 6042-F(P2) Dated, 7th November, 2019.

2. Prior to 01.07.2022, the basic pay of Shri Biswajit Patra in the post of Executive Engineer (Civil) was Rs 90,400/- in pay level 17 of ROPA Rules, 2019.

3. Shri Biswajit Patra has exercised his option to fix his pay w.e.f 01.07.2022 & 01.08.2023 respectively.

4. Now, as per the option exercised by Shri Biswajit Patra, his pay is hereby fixed as follows:
