**NOTICE INVITING TENDER (2<sup>nd</sup> CALL)**

**Subject :-Supply & Installation of RO+UV water purifier with storage cooler cum purifier with in built purification system.**

Sealed Tenders are invited from the reputed Companies/Dealers/Authorised Agencies/Distributors, by the Joint Secretary, P&RD Department, Joint Administrative Building, Block HC-7, Sector-III, Salt Lake, Kolkata-700 106, for supplying and installation of 05(five) pcs of water purifier for the use of the Officers/Employees/ Visitors likely to be 80 to 100 people per floor during working hours. The specification of the purifier is stated below :-

1. RO+UV/UF, water purifier, based with 20"(inch) pre filter with iron remover (minimum 5 stage purification).
2. Water storage cooler cum purifier with in-built purification system.
3. The storage container shall be of SS 304 with minimum storage capacity 80 litres with cooling capacity not less than 60 litres/hour.
4. Purified water production capacity should be minimum 30 litre/hour.
5. The output water quality shall comply with IS :10500-2012.
6. Provision for last point purification refrigerant.
7. No. of faucets-2 nos. (for cold).
8. Certified by ISO 9001 & 14001 (for sales & services).
9. 2 KVA voltage stabilizer (01 No.).
10. Material / equipment to be supplied must have minimum 1 year onsite warranty / guarantee period of the entire system.

The quality of water purifier should be strictly maintained by the respective company. The water purifier is to be installed on and from the 6<sup>th</sup> floor to 10<sup>th</sup> floor of this office premises. The terms of reference of the work for which the quotation is invited includes requirement based designing, supplying, fitting/fixing of the water purifying units and commissioning the same including fixing of user guide (Do's & Don't's) in laminated bond within fifteen days from the date of work order failing which the earnest money (EM)(2% of the quoted value) will be forfeited. The EM of the unsuccessful quotationers shall be returned within ten days from the date of opening the quotations. The intending quotationers must have executed similar nature of work, of volume not less than one third of the value of this quotation, within last three years from the date of the notice inviting this quotation.

The quotationer must submit the followings alongwith the quotation of rate : (i) Registration No. & date of their Company/Firm/Agency. (ii) GST registration No./ PAN No. (iii) Earnest money @ 2% of the quoted value in the shape of a B.G./D.D. in favour of "WBSRDA in DRDA-Accounts-Admin Fund". iv) From the successful bidders bill an amount of 8% to be deducted as security deposit aggregating including the earnest money as 10% which will be refunded after defect liability period as mentioned in the defect liability clause.

Stipulated time of installation of all units in all respect is 10 days from the date of issue of the work order.

Defect liability period of the work is 90 days from the date of completion of all units and the earnest money including the 8% Security Deposit money of the successful bidder will be refunded after the said period of 90 days.

Advance payment is not possible. Payment shall normally be made within 2-3 weeks after installation of the purifier.

Quotation must be submitted before the office of the Deputy Secretary within 2p.m. of 28<sup>th</sup> May, 2018 in every working day.

Last date of submission of quotation is 28<sup>th</sup> May, 2018 at 2p.m..

Date of opening the quotation is 28<sup>th</sup> May, 2018, at the chamber of the Deputy Secretary (Estt.) at 3 p.m.

Authority reserves the right to accept or reject any quotation without assigning any reason thereof.


