WHEREAS, the Principal Bench, Hon`ble National Green Tribunal has on 02.04.2019 in the O.A. No. 606/ 2018 has directed upon the Government of West Bengal under Para 39. i of Clause IV of the valued order of the Hon`ble Principal Bench of the Tribunal that at least 3 (three) Gram Panchayats in every district of the State shall be made fully compliant of the stipulations of the Solid Waste Management Rules, 2016 and the Plastic Waste Management Rules, 2016 and list of such identified Gram Panchayats shall be notified on the website of the Department;

And WHEREAS, the Panchayats & Rural Development Department had notified the list of 69 model Gram Panchayats of all 23 districts in the state to set up comprehensive plan of action and to make it fully compliant in the context of Solid and Plastic Waste Management vide No. 3594-RD/PH&S/S/1E-4/2019 dated 21.05.2019 on the departmental website and the website of West Bengal Pollution Control Board;

And WHEREAS, 3 (three) districts have requested to replace one or more of earlier notified Gram Panchayats as per the following details;

- i) Malda – 3 Gram Panchayats
- ii) Murshidabad – 1 Gram Panchayat
- iii) Kalimpong – 1 Gram Panchayat

NOW therefore; in compliance of the directions of Hon`ble NGT, the Governor is pleased to notify the following changes in the list of model Gram Panchayats in Malda, Murshidabad and Kalimpong districts which shall be taken up for comprehensive action for setting up desired level of Solid and Plastic Waste Management practices as envisaged in the above stated regulations.
