

1. Each incumbent has to submit a declaration in the prescribed Form under Rule-9 of the WBSR-I before joining.
2. The candidates shall have to join their place of posting within 30 (thirty) days, failing which their candidature will be cancelled and no correspondence in this matter will be entertained by this Department.
3. This order is issued in the interest of Public Service.

4. No travel expenses shall be admissible for undertaking the journey for joining in the Block.
5. The appointment is made on the basis of the results of the WBCS (Exe).Etc. Examination 2017 Gr.-C Services & Posts conducted by Public Service Commission, West Bengal, after verification of antecedents. The service being transferable, the incumbents shall be liable to be transferred to any part of the State at any time in the interest of public service.
6. The incumbent shall have to undergo a compulsory induction training at the B.R. Ambedkar Institute of Panchayats and Rural Development Department, Kalyani or elsewhere as per training schedule, which will be communicated in due course.
7. It is hereby certified as per Note 3(i) under rule 11 of WBSR, Pt-1 that the medical certificate in the prescribed proforma has been obtained in respect of all above mentioned candidates prior to their appointment and nothing adverse has been found.
8. The Accountant General (A&E) West Bengal and the Treasury Officers concerned are being informed.
