Examination 2020 Gr.-C Services & Posts conducted by Public Service Commission, West Bengal, after verification of the antecedents. As the service is transferable, the incumbent shall be liable to be transferred at any part of the State at any time in the interest of public service as and when required.
6. It is hereby certified as per Note 3 (i) under rule 11 of WBSR, Pt-1 that the medical certificate in the prescribed proforma has been obtained in respect of the mentioned candidate prior to his appointment and nothing adverse has been found and kept in this Department.
