  (A) dated 18.04.2024 of Public Service Commission, West Bengal on the basis of the results of the WBCS (Exe).etc. Examination 2021 Gr.-C Services & Posts. As the service is transferable, the incumbents shall be liable to be transferred at any part of the State at any time as and when required.
- 5. As per Note 3 (i) under rule 11 of WBSR, Pt-1 it is hereby certified that the satisfactory medical certificate in the prescribed proforma has been obtained in respect of the incumbents prior to their appointment and kept in this Department.
- 6. It is hereby certified that the satisfactory Police Verification Roll have been received in respect of the incumbents and kept in this Department.

- 8. The appointment is provisional and subject to the authenticity of the certificates as produced by the incumbents during verification of antecedents. If, in future course of time, the authenticity of those certificates are found to be false, the service of the incumbents will be terminated forthwith without assigning any further reasons & without prejudice to such further action as may be taken under the extant laws of the land for production of false certificates.
