ORDER

In pursuance of P&RD Department's Notification No: 789-RD/O/13E-07/2023, dated: 19.02.2025, Shri Anindya Guha, Executive Engineer(Civil) under West Bengal Senior Service of engineers (Civil) in Panchayats and Rural Development Department is hereby allowed to get fifteen years (15) MCAS Benefit in terms of Finance Department's Memo No: 6042-F, dated: 07.11.2019 read with Memo No: 5100-F(P1)/FA/O/2M/46/23 (N.B) dated: 31.08.2023 w.e.f 01.08.2023.

- 2. Prior to 01.08.2023, the basic pay of Shri Anindya Guha in the post of Executive Engineer (Civil) was Rs 95900/- in pay level 17 of ROPA Rules, 2019.
