
The appointment is being made subject to following conditions.

1. The incumbents will report to Director, B.R. Ambedkar Institution of Panchayats and Rural Development (BRAIPRD), West Bengal, B- 18/204, Kalyani, District- Nadia, on 31.12.2025 in the forenoon positively which will be treated as date of joining as Joint Block Development Officer.
2. Each incumbent will have to submit a declaration in the prescribed form under Rule 9 of the WBSR – I before joining.
3. Incumbents will be posted at different Blocks on completion of training at BRAIPARD, Kalyani, Nadia and posting order will be issued in due course.
4. The appointment is made on the basis of the results of the WBCS (Exe.)Etc. Examination, 2022, Gr. C Services and posts conducted by the Public Service Commission, West Bengal. The service being transferrable, the incumbents shall be liable to be transferred to any part of the State at any time in the interest of public service.
5. This order is issued in the interest of public service.



6. The positions of the candidates in the Gradation List of Joint Block Development Officers will be determined after regularization of their services in the post of Joint Block Development Officer in due course.
7. The Deputy Director (Finance), BRAIPRD, Kalyani is hereby declared as Drawing and Disbursing Officer in respect of Joint Block Development Officers concerned during training period and the fund will be met from the grant under the head "2515-00-102-NP-001-Block Headquarters [PN]-V-01-Salaries etc".
8. As per Note 3 (i) under rule 11 of WBSR, Pt-1 it is hereby certified that the satisfactory medical certificates in the prescribed proforma have been obtained in respect of the incumbents prior to their appointment and kept in this Department.
9. It is hereby certified that the satisfactory Police Verification Rolls have been received in respect of the incumbents and kept in this Department.
10. The Accountant General (A&E) West Bengal and the Treasury Officer concerned are being informed.


