Kolkata, the 27th July, 2023**NOTIFICATION**

In exercise of the power conferred by sub-section (3) of section 140 of the West Bengal *Panchayat* Act, 1973 (West Ben. Act XLI of 1973), read with Notification No. 4073/PN/O/I/1E-03/2023 dated 06/07/2023 of the Department of Panchayats & Rural Development, Government of West Bengal and also in terms of section 77 of the West Bengal Panchayat Elections Act, 2003 read with rule 107(3) of the West Bengal *Panchayat* Elections Rules, 2006 I, Shri Biswajit Dutta, Commissioner, Panchayats & Rural Development, West Bengal, do hereby notify in the Official Gazette the *Zilla Parishad* constituted in the district of Dakshin Dinajpur as mentioned in table below and also publish the names of the members elected to the aforesaid *Zilla Parishad* in the Panchayat General Elections held in 2023 showing the corresponding *Zilla Parishad* constituencies from which they are elected along with the *ex-officio* members of the said *Zilla Parishad*.

It is further notified that, notwithstanding the description of members in the table following, (i) the Sabhapatis of Panchayat Samitis within the *Zilla Parishad* area; (ii) members of the House of the People and the Legislative Assembly of the State elected thereto from a constituency comprising the District, not being Ministers or simultaneously directly elected members of *Zilla Parishad*; (iii) members of the Council of States, not being Ministers [registered as electors within the area of any Block] within the District will be *ex-officio* members of the *Zilla Parishad* under sub-section 2 of section 140 of the West Bengal *Panchayat* Act, 1973 (West Ben. Act XLI of 1973).
