## <u>ORDER</u>

Shri Kali Sadhan Mukherjee, Junior Engineer (Civil) under RWP Set Up of Panchayats and Rural Development Department, presently posted at Murarai-I Dev. Block, Birbhum, was appointed as a Nirman Sahayak vide Order No: 255, dated: 02.07.2010 issued by Cooch Behar Zilla Parishad in the pay scale of Rs (9000-40500)/- with Grade Pay of Rs 4400/- as per WBS (ROPA) Rules, 2009. Shri Kali Sadhan Mukherjee joined as a Nirman Sahayak in Brahmatar Chatra Gram Panchayat, Sitai Dev. Block, Birbhum district on 19.07.2010 (F.N.) in pursuance of Memo No: 2161/(65)/CZP/VI-3/09, dated: 02.07.2010 issued by Cooch Behar Zilla Parishad.

Later, his service as a Nirman Sahayak was confirmed on 19.07.2013 vide Order No: 1461/DP&RDO, dated: 06.08.2024 issued by the Office of the District Magistrate, Birbhum.

Then, having been selected in the Sub-Assistant (Civil) Recruitment Examination conducted by PSC, WB and in pursuance of Order No: 4826-RD/O/13E-06/2017, dated: 15.09.2017 & Revised Order No: 1223/RD/O/13E-09/2017, dated: 27.02.2018 both issued by the Panchayats and Rural Development Department, Shri Kali Sadhan Mukherjee was appointed to the post of Junior Engineer (Civil) under RWP Set Up of Panchayats and Rural Development Department. He joined as a Junior Engineer (Civil) in Khargram Dev. Block, Birbhum vide Memo No: 229(9), dated: 13.03.2018 issued by the Block Development Office of Khargram, Birbhum on 13.03.2018(F.N.) after being released from the post of Nirman sahayak on 12.03.2018 (A.N.) vide Order No- 402(10)/Nal-I/18, dated: 12.03.2018 issued by the Block Development Office of Nalhati-I, Birbhum.

Now, the Governor is pleased to accord approval to count the previous service from **19.07.2010 (F.N.) to 12.03.2018 (A.N.)** as rendered by Shri Kali Sadhan Mukherjee, Junior Engineer (Civil) in his erstwhile post of Nirman Sahayak in terms of Finance (Pension) Department's Memorandum No: 249-F(Pen), dated: 27.05.2019 read with Rule 33(2) of WBS (D.C.R.B) Rules 1971, for the purpose of pensionary benefit only.

However, the previous service of Shri Kali Sadhan Mukherjee cannot be counted for seniority and MCAS'2001 Benefit for his present service in West Bengal Engineering Services.
