ORDER

In cancellation of this Department's previous Order No. 2258/PRD-31011(11)/14/2025-JRY SEC Dept. Of PRD dated 16.05.2025 it is hereby informed that in pursuance of P&RD Department's Notification No: 1664-RD/O/13E-09/2024, dated: 07.04.2025, Smt Lima Biswas, Assistant Engineer(Civil) under West Bengal Service of Engineers (Civil) in Panchayats and Rural Development Department is hereby allowed to get of Higher Scale Benefit six (06) years in terms of Finance Department's Memo No: 8555-F, dated: 18.09.1985w.e.f 19.03.2024 and the annual increment of Smt. Biswas which had been stopped as per Order No: 461(25)-PRD-23098/7/2023-Estt. SEC-Dept. Of PRD, dated 20.01.2023 will again start from the date of confirmation i.e. 19.03.2024.

- 2. Prior to 30.06.2023, the basic pay of Smt Lima Biswas, Assistant Engineer (Civil) was Rs 69000/- in pay level 16 of ROPA Rules, 2019.
- 3. Smt Lima Biswas has exercised her option to fix her pay w.e.f 01.07.2024.
