

Selection of Biogas turnkey workers/Rural Energy Technicians

To construct Family Type Biogas Plants or Small Biogas Plants (1CuM size, 2-6 Cum size, 8-10 CuM size, 15CuM size & 20-25 CuM size) under New National Biogas and Organic manure Programme (henceforth mentioned as NNBOMP), Ministry of New and Renewable Energy; Panchyats & Rural Development, Government of West Bengal desires to enlist Biogas Turn-Key workers/Rural Energy Technicians. For this purpose, to implement the programme as per guideline of NNBOMP, Biogas Turn-Key workers /Rural Energy Technicians may submit their application in the proforma annexed herewith to Mission Director, SBM(G) & Additional Secretary, Panchyats & Rural Development Department, 8th Floor, Joint Administrative Building, Kolkata 700106 by 30.06.2025.

Eligibility Criteria of application:

- 1.Biogas Trun-Key workers/Rural Energy Technicians (hence forth mentioned as applications) already registered by any department of Government of West Bengal or KVIC or BDTC from previous years and who have been involved and have implemented the earlier NNBOMP in the past without any complaints. Documents from concerned organization will have to be submitted by the applicant as proof.
- 2. Applicants who have constructed biogas plants, either Family Type Biogas Plants or Small Biogas Plants under NNBOMP without any complaint, documentary proof of receiving subsidy as per NNBOMP norm from concerned department/KVIC/BDTC only will be treated as proof of no. of Family Type Biogas Plants or Small Biogas Plants or small Biogas plants constructed by applicant.
- 3. Applicants may apply for construction of anyone or more than one category of Family Type Biogas Plants or Small Biogas Plants and it should be clearly mentioned in the application.

Manner of Construction

Selected application, in the matter of construction of family Type Biogas Plants or Small Biogas Plants, have to abide by all the conditions including payment of Trun-Key Work Fee(TKWF), specification of Family Type Biogas plants or Small Biogas plants including Prefabricated Biogas Plants, Biogas plants appliances, verification, O&M services and post insulation free service for at least five years after plant commissioning as mentioned in the 126/1/2023-BIOGAS dated 01.04.2025(copy enclosed) issued by Ministry of New and Renewable Energy, Government of India and as may be modified time to time.

Identification of beneficiary:

- 1. Panchyats & Rural development Department and applicant, if selected, will identify eligible beneficiaries.
- 2. Area of operation for construction of biogas plants may be done among the applications. Decision of Panchyats & Rural Department will be final in this respect.
