ORDER

In pursuance of P & R. D. Department's Notification No. 661/PRD-31011/4/2023-JRY SEC-Deptt. Of PRD dated 09.02.2026, Shri Prosenjit Dhak, Junior Engineer (Civil) under RWP Set Up in Panchayats and Rural Development Department, presently posted at WBSRDA, Purba Bardhaman Division, is hereby allowed to get eight (08) years MCAS benefit in terms of Finance Department's Memo No. 8555-F, dated 18.09.1985 w.e.f. 21.09.2025.

2. Prior to 21.09.2025, the basic pay of Shri Prosenjit Dhak in the post of Junior Engineer (Civil) was Rs 45,300/- in pay level 12 of ROPA Rules, 2019.

3. Shri Prosenjit Dhak has exercised his option to fix his pay w.e.f 21.09.2025.

4. Now, as per the option exercised by Shri Prosenjit Dhak, his pay is hereby fixed as follows:

Thus, the pay of Shri Prosenjit Dhak is finally fixed at Rs 48,400/- under Pay Level 13 Rs. Rs (37,100-95,500) of ROPA Rules, 2019.
