Sub: Grant of Dearness Allowance to the employees of Panchayat Bodies and Dearness Relief to the Pensioners/ Family Pensioners of Panchayat Bodies with effect from 1st January, 2024

ORDER

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction the benefit of Dearness Allowance @ 10% of basic pay with effect from 01.01.2024 in respect of the whole time employees of Panchayat Bodies (three tiers) including Panchayat Karmee who are drawing their Pay in the revised pay structure implemented as per recommendations of the 6th Pay Commission. The calculation of Dearness Allowances shall be made taking into account the revised basic pay and N.P.A., if any, but it shall not include any other type of pay.

2. The Pensioners/ Family Pensioners of Panchayat Bodies (Three tiers), who are in receipt of revised Pension/ revised Family Pension as per recommendations of 6th Pay Commission shall draw Dearness Relief @ 10% with effect from 01.01.2024.

3. (a) The rate of Dearness Allowance in respect of the whole time employees of Panchayat Bodies (three tiers) including Panchayat Karmee who are drawing pay in the pre revised pay structure as per recommendations of the 5th Pay Commission shall be enhanced from 141% to 151% with effect from 01.01.2024.

(b) The pensioners/ family pensioners of Panchayat Bodies (three tiers) still drawing pre-revised pension/ family pension (As per ROPA 2009) will get Dearness Relief @ 151% with effect from 01.01.2024 till their pension/ family pension is revised.

4. The Dearness Allowance/ Dearness Relief sanctioned herein above shall be rounded off to the nearest rupee in each case.
