The intending bidders must have completed at least one work of similar nature in a single contract not less than the value of Rs. **800000** (Rupees Eight Lakh only) **in each of two separate contracts** within last 5 (five) years from the date of NIT.

1. Payment of Earnest money: - Earnest money shall be deposited by the bidder in online mode only through Net Banking / RTGS/ NEFT in respect of Tender ID in favour of **HOWRAH WBSRLM NRLM FUND A/C.**

2. Additional Performance Security:- On receiving of the bid, If it is found, the Tendered amount is 80% or Below of the Estimated amount, the L1 Bidder should have to deposit Additional Performance Security @ 10% of the Tendered amount in the form of Bank Guaranty in favour of **HOWRAH WBSRLM NRLM FUND A/C** for the entire contract period within 7(Seven) days from the date of issuance of LOI. The B.G will be returned immediately on successful completion of the contract.

3. Pre-Qualification / Technical criteria for participation in tender:-

c) The Company/agency/MSME should have a permanent office at Howrah District.

If any document submitted by a bidder is either manufactured or false, in such cases the eligibility of the bidder will be out rightly rejected at any stage without any prejudice.

a) Certificates:-

- i) A signed copy of the Tender Notice, a declaration and a check-list to be signed and uploaded by the participating bidder.
- ii) Scanned copy of valid up to date Professional Tax receipt Challan
- iii) GST as per latest Govt. order
- iv) PAN card issued by Income Tax Department
- v) Valid I.T.R. (Income tax return) for the latest three consecutive years (2020-21), (2021-22) & (2022-23)
- vi) Latest 3yrs. audited balance sheet including P& L account statements (2020-21), (2021-22) & (2022-23).
- vii) Credentials having similar nature of works, Work Order, SOQ and payment certificate of the said work to be submitted.
- viii) Registration Certificate and/or trade license of the company must be submitted **duly digitally signed** at desired location in the website <https://wbtenders.gov.in>.

A partnership firm will have to furnish the registered partnership deed and a company will have to furnish the Article of Association and Memorandum.

Supply Orders and / or Payment Certificates shall not be accepted as Credential. Completion Certificate will be accepted as Credential.

All duties , royalties , cess , including 1% cess under W.B. Building and other construction, Workers (Regulation of Employment & condition of service) Act, 1961, toll, taxes and other levies payable by the contractor (Regulation of Employment & condition of service) Welfare cess Act, 1996 will be deducted from the running under the contract to the state/central Government for any other cause, shall be included in the rates, prices and total Bid price submitted by the bidder. 1% cess under W.B. Building and other construction workers bills.

b) Experience / Credential:-

The intending bidders must have completed at least one work of similar nature in a single contract not less than the value of Rs. **800000/-** (Rupees Eight Lakh only) in each of two separate contracts within last 5 (five) years from the date of NIT.

Payment certificate will not be treated as credential.

NOTE:-

- A prospective bidder shall be allowed to participate in the particular Job either in the capacity of individual or as a partner of a firm. If found to have applied severally for a single job, all his applications will be rejected for that job, without assigning any reason thereof.
- **No Mobilization Advance and Secured Advance will be allowed.**
- **There will be no provision of Arbitration.** Settlement of Dispute (refer to Clause no.25 of Form 2911)

- No **CONDITIONAL/ INCOMPLETE TENDER** will be accepted under any circumstances.
- In case there is any objection regarding prequalifying of an agency, that should be lodged to the Tender Selection Committee, Addl District Mission Director within 48 (*forty eight*) hours (*including holidays*) from the date and time of publication of list of qualified agencies and beyond that time schedule no objection will be entertained by the Tender Selection Committee.
- The unit rates and the prices shall be quoted by the bidder entirely in Indian Rupees up to two decimal places.
- Under no circumstances Escalation in prices in materials, labour charges, cost of P.O.L. & arbitration will be entertained.
- The Employer requires the bidders / Contractors to strictly observe the laws against fraud and corruption in force in India, namely, Prevention of Corruption Act, 1988.
- There will be no price preference to any bidder.
- No interest claim will be admissible during refund of earnest money and security deposit.
- Any bill (running account/final) payment of proposed work/supply may be made to Agency as per availability of fund.
- Time allowed for completion of work will be measured from the date of issue of work order
- If any erroneous printing found after agreement or any time in the BOQ (Bill of Quantity) Quantity or Rate, the Tender Inviting authority reserve the rights to correct the same as per approved original estimate.
- The engaged contractor will have to get registered under BOCW (RECS) act and shall have to contribute towards " The West Bengal Building and other Construction Workers' welfare fund" @ 1% (One percent) of the gross amount of the work by way of deduction from Running and /or final bill.
- Even though the bidders meet the above qualifying criteria, they are subject to be disqualified if they have:
 - (i) Made misleading or false representations in the forms, statements, affidavits and attachments submitted in proof of the qualification requirements; and / or record of submission of any false / fake document(s).
 - (ii) Record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion, litigation history, or financial failures etc.
 - (iii) Participated in the previous bidding for the same work and had quoted unreasonably high or low bid prices and could not furnish rational justification for it to the Employer.
- The successful bidder shall have to abide by all the labour related and other rules , regulations and laws of the land and the Tender Inviting Authority in no way shall be held responsible for financial or any other consequences arising out of non his non compliance of the same.

accordingly. Time will be reckoned as per Server Clock. The Financial Bid of the Participant tenderer will be opened only if the tenderer qualifies in the Technical Bid evaluation.

The Authority reserves the right to reject the lowest tender/ all the tenders without assigning any reason whatsoever.


