- (d) Copy of at least one work order /credential certificate from Government Offices/Government undertaking.


3. Interested Agencies may visit to this office to see the condition of ACs at any working day other than Saturday, Sunday and Govt. Holiday.

4. **Opening of Bid** and its evaluation - On 25.04.2023 at 3 (PM) in presence of interested Bidders.

5. **Award of Contract :** The WBSRLM will issue order for the above services to L1 Bidder by 26.04.2023 positively. L-1 Bidder will be considered based on the Total amount quoted as per para 1(a)+(b) above. There will be a negotiation of rate for "Gas Filling (Full) with repairing licking" of AC, if other agency quoted lower than the L-1 Agency. Initially servicing of all 19 ACs will be done and thereafter "Gas Top Up" will be done where necessary.

6. Notwithstanding the above, the WBSRLM reserves the right to accept or reject any quotations and to cancel the Bidding process and reject all quotations at any time prior to the award of contract. Selection (L-1) will be considered on the basis of Lowest amount of above services quoted by the Bidder.

7. Payment will be made with in 10 days on submission of bill. This has the approval of the CEO at Note#42 dated 17.04.2023.
